



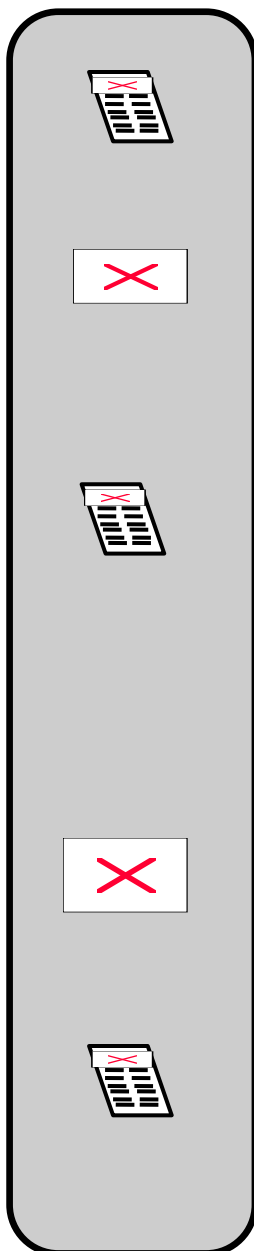

1. **Application Form.** Attached to this packet.
2. **Application Fee:** Annexation: \$3,800.  
Environmental review: \$2,555 for Negative Declaration; or \$550 deposit plus actual cost for EIR.  
**NOTE:** This fee does not include Fresno County Local Agency Formation Commission (LAFCo), California Board of Equalization fees or Cal Dept. of Fish and Game fees required to record the environmental documents.
3. **Environmental Description Form.** Annexations are required to be reviewed for their potential impacts on the environment. An environmental description form is attached with this packet.

#### **ANNEXATION MAP AND LEGAL DESCRIPTION**

4. **Twenty (20) copies of a map showing the proposed annexation.** The map shall be drawn by a licensed surveyor or registered civil engineer, according to requirements of the Fresno County Local Agency Formation Commission.
5. **Twenty (20) copies of a legal description of the subject site.** The legal description shall be prepared by a licensed surveyor or registered civil engineer, according to requirements of the Fresno County Local Agency Formation Commission.
