WHEREAS, ATTORNEY has the necessary education, experience, skills and expertise to serve as the City Attorney; and,

WHEREAS, said CLIENT employs ATTORNEY to represent the CLIENT in all matters as the designated City Attorney, who is responsible for the legal representation of the CLIENT.

NOW THEREFORE the parties mutually agree to the terms, covenants and conditions set forth below.

#### **AGREEMENT**

#### 1. Services

ATTORNEY is empowered and agrees to perform all services as ATTORNEY that she deems proper, necessary and/or appropriate. ATTORNEY shall provide City Attorney legal services to CLIENT called for under this Agreement, keep CLIENT informed of progress and developments, and respond promptly to CLIENT'S inquiries and communications. The specific services are listed below in the Scope of Work.

#### 2. Scope of Work

#### 2.1 Non-litigation and General Legal Services

These shall generally include the following services: attendance at two (2) regularly-scheduled monthly City Council meetings; attendance at up to two (2) special meetings with City Council and/or staff; on-call telephone and email response to general legal questions; attendance at telephonic City Council Meeting Agenda preparation meetings with staff; preparation of legal documents (i.e. resolutions, ordinances, and contracts) and preparation of legal opinions related to the above legal services. These services shall be performed under the Non-Litigation and General Legal Services rate, as outlined in Sub-Section 5.1.

#### 2.2 <u>Litigation and Special Legal Services</u>

These shall generally include services outside of Non-Litigation and General Legal Services, above,, including but not limited to litigation, contested personnel/employment/labor/ union matters, , mediation, administrative hearings, coordination with outside litigation counsel, and special projects, such as review and revision of Personnel Rules. These services shall be performed under the Litigation and Special Legal Services rate, as outlined in Sub-Section 5.2.

#### 2.3 General Scope Provisions

ATTORNEY is responsible for providing all reasonable and necessary facilities, equipment, books, supplies and secretarial services, as necessary to carry out and provide the required legal services. ATTORNEY is specifically designated as the City Attorney, David A. Fike is designated as the Assistant Attorney, unless the parties agree otherwise, and ATTORNEY may provide other attorneys to represent CLIENT as needed.

In order to maintain peak efficiency and effectiveness as City Attorney, CLIENT may require attendance by ATTORNEY at continuing legal education seminars, including but not limited to, one (1) League of California Cities Conference per year. If so, CLIENT shall pre-approve the associated costs and attendance at those legal education seminars, and reimburse ATTORNEY for all expenses relating to such seminars, including travel, lodging, registration, and other fees.

#### 3. Term

This Agreement is effective July 1, 2016, upon approval of CLIENT, and shall remain effective until modified and/or terminated, as provided in this Agreement.

#### 4. Performance Evaluation

- 4.1 CLIENT may review and evaluate the performance of ATTORNEY at least once annually commencing one year from the effective date of this Agreement. Said review and evaluation shall be in accordance with specific criteria developed jointly by CLIENT and ATTORNEY. Said criteria may be modified as CLIENT may from time to time determine, in consultation with ATTORNEY. Further, CLIENT shall provide ATTORNEY with a written summary of its evaluation and provide an adequate opportunity for ATTORNEY to review and discuss it with CLIENT
- 4.2 Annually, commencing on the effective date of this Agreement, CLIENT and ATTORNEY may define in writing such goals and performance objectives that they jointly determine necessary for their continued successful professional relationships.

#### 5. Billing and Rates

#### 5.1 Non-Litigation and General Legal Services Rate

The monthly retainer fee for these services shall be in the amount of \$6,500.00. This retainer fee shall also include, but not be limited to, duplication costs, word processing costs, travel, long-distance telephone and telecommunication costs, postage/mail costs, facsimile transmissions, electronic mail and other costs customarily made as part of the performance of legal services by ATTORNEY, as described in Sub-Section 2.1. Billing for the retainer fee shall be made at the first of each month in advance, with payment of the same due and payable by the first City Council Meeting of each month.

#### 5.2 Litigation and Special Legal Services Rate

For all costs and the services outside of the retainer, as described in Sub-Section 2.2, an hourly rate of one hundred ninety five dollars (\$195) per hour shall be charged, plus actual costs. Such billings shall be in a minimum of one-tenth (1/10) hour increments and shall be billed monthly in arrears, payable on or before the 15<sup>th</sup> of each month.

#### 5.3 Billing Provisions

Actual costs shall be billed without markup and shall only be for litigation-related expenses, other expenses allowed by this Agreement or specifically authorized by the City Manager. Any allowable gas and mileage expenses shall be billed at the then current IRS rate. CLIENT is informed that these costs are not set by law, but rather are negotiable between the ATTORNEY and CLIENT.

#### 6. Other Representation

CLIENT is informed that the Rules of Professional Conduct of the State Bar of California require the CLIENT's informed written consent before an attorney may begin or continue to represent the CLIENT when the ATTORNEY may begin or continue to represent another client that may have or had a relationship with another party interested in the subject matter of the ATTORNEY's proposed representation of the CLIENT. As long as ATTORNEY's services for CLIENT continue under this Agreement, ATTORNEY will not agree to provide legal services for any such party without CLIENT's prior written consent.

#### 7. Client Commitments

CLIENT will be truthful and cooperative with ATTORNEY, keep ATTORNEY reasonably informed of developments and of CLIENT's address, telephone number, and whereabouts and timely make any payments required by this Agreement.

#### 8. Termination

#### 8.1 CLIENT Termination

CLIENT may discharge ATTORNEY by providing thirty (30) days written notice. Unless specifically agreed by ATTORNEY and CLIENT, ATTORNEY will provide no further services and advance no further costs on CLIENT's behalf after receipt of the notice.

#### **8.2 ATTORNEY Termination**

ATTORNEY may withdraw, as permitted under the Rules of Professional Conduct of the State Bar of California, by providing thirty (30) days written notice. The circumstances under which the rules permit such withdrawal include, but are not limited to: (a) the client consents; (b) the client's conduct renders it unreasonably difficult for the attorney to carry out the employment effectively; or (c) the client fails to pay attorney's fees or costs as required by his or her agreement with the attorney. Notwithstanding ATTORNEY's withdrawal, CLIENT will be obligated to pay ATTORNEY reasonable attorney's fees for all services provided and to reimburse ATTORNEY in full for costs advanced.

#### 8.3 CLIENT Papers and Property

At the termination of services under this Agreement, ATTORNEY will release promptly to CLIENT on request all of CLIENT'S papers and property (subject to any protective order or non-disclosure agreement). "CLIENT'S papers and property" include correspondence, deposition transcripts, exhibits, experts' reports, legal documents, physical evidence, and other items reasonably necessary to CLIENT'S representation, whether CLIENT has paid for them or not.

#### 9. Insurance

ATTORNEY shall maintain errors and omissions and/or legal malpractice insurance in the amount of one million dollars (\$1,000,000), applicable to the services to be rendered under this Agreement; proof of which shall be provided to the City Manager, along with that of current automobile insurance.

#### 10. Assignment

ATTORNEY shall not assign any of her obligations imposed pursuant to the provisions of this Agreement without the prior written consent of the CLIENT.

#### 11. Non-Waiver

It is expressly agreed that the CLIENT'S failure to terminate this Agreement for any violation or failure to perform by ATTORNEY shall not be construed as a waiver of any provisions herein.

#### 12. Notices

Notices pursuant to this Agreement shall be in writing, and shall be given by personal service upon the party to be notified, or by United States Postal Service or its lawful successor, postage prepaid, addressed as follows:

#### 13. Governing Law and Venue

It is understood and agreed by the parties hereto, that the laws of the State of California shall govern the rights, obligations, duties and liabilities of the parties to this Agreement. In the event of litigation related to this Agreement, venue shall be the state courts located in Fresno County.

#### 14. Binding Effect of Agreement

This Agreement shall be binding upon the parties hereto and upon all of their lawful successors in interest.

#### 15. Entirety

The parties agree that this Agreement represents the full and entire Agreement between the parties hereto with respect to the matters covered herein.

#### 16. Survivability

If any provision of this Agreement is held in whole or in part to be unenforceable for any reason, the remainder of that provision and of the entire Agreement will be severable and remain in effect.

#### 17. Authority

Each of the representatives signing this Agreement represents that he or she is duly authorized to enter into this Agreement on behalf of the party or entity for which he or she is signing.

#### 18. Modification

This Agreement may be modified by subsequent agreement of the parties only by instrument in writing signed by both parties.

#### 19. Dispute Resolution

If a dispute arises between ATTORNEY and CLIENT regarding attorney's fees under this Agreement and ATTORNEY files suit in any court other than small claims court, CLIENT will have the right to stay that suit by timely electing to arbitrate the dispute under Business and Professions Code section 6200-6206, in which event ATTORNEY must submit the matter to such arbitration.

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH APPROVING A STEP INCREASE TO BEN GALLEGOS AS ACTING CITY MANAGER

**WHEREAS**, the City of Firebaugh hereby brings forth a resolution approving a step increase to Ben Gallegos, as acting City Manager pursuant to a satisfactory evaluation;

WHEREAS, the City of Firebaugh is authorized by the laws of the State of California and Firebaugh Municipal Code to appoint an acting City Manager, whom shall have all of the power and authority that is vested in the City Manager; and

**WHEREAS,** the City Council of the City of Firebaugh appointed Ben Gallegos to served as the acting City Manager of the City, effective January 1, 2016,

**WHEREAS**, the City of Firebaugh desire to enter into an agreement with Ben Gallegos, a current City employee, to continue to serve as acting City Manager in accordance with the following terms as of January 1, 2016:

- (1) Mr. Gallegos shall have all of the powers and authority vested in the City Manager;
- (2) Mr. Gallegos shall perform the duties prescribed in the Firebaugh Municipal Code and under California law for a City Manager;
  - (3) Mr. Gallegos shall also perform such additional duties as may be assigned by the City Council;
  - (4) Mr. Gallegos shall continue to serve as the Public Works Director for the City;
- (5) Mr. Gallegos shall serve as acting City Manager for a period of one (1) year beginning on January 1, 2016, and ending on January 1, 2017, unless replaced at an earlier time by request of either Mr. Gallegos or the City of Firebaugh;
- (6) The City agreed to pay Mr. Gallegos a salary of \$114,000.00 annually (\$9,500.00 per month) Step 6 of the City Manager pay scale salary as long as he serves as acting City Manager;
- (7) Mr. Gallegos shall receive a performance evaluation at six (6) months from the effective date of his appointment, or more often as may be requested by the City Council or Mr. Gallegos;
- (8) The City shall continue to pay for all licenses and certificates necessary for Mr. Gallegos to continue serving as the Public Works Director;
- (9) During the term of Mr. Gallegos' appointment, upon approval of a majority of the City Council, he is authorized to utilize a consultant or consultants to aid in the performance of his duties as City Manager;
- (10) Termination or expiration of the acting City Manager appointment shall have no impact on Mr. Gallegos' employment as Public Works Director, and
- (11) Mr. Gallegos shall return to his position as the Public Works Director for the City of Firebaugh and his annual salary shall return to the amount applicable as the Public Works Director.
- **WHEREAS**, Ben Gallegos has served as acting City Manager for 6 month and received a satisfactory evaluation at a regular Council Meeting on June 20, 2016, and;
- **WHEREAS**, the City Council of the City of Firebaugh approved a salary step increase from Step 6 to Step 7 of the City Managers pay scale equaling \$118,000.00 annually (\$9,833.33 per month).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FIREBAUGH, CALIFORNIA that the City of Firebaugh hereby approves a salary step increase to Ben Gallegos as acting City Manager from Step 6 to Step 7, effective July 2, 2016..

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH ENACTING CHAPTER 8.8 OF THE FIREBAUGH MUNICIPAL CODE RELATING TO IMPACT FEES FOR DEVELOPMENT PROJECTS

The City Council of the City of Firebaugh does hereby ordain as follows:

SECTION 1: Chapter 8.8 is added to the Firebaugh Municipal Code, to read as follows:

- 8.8-1: Authority to Impose and Charge Development Impact Fees
- 8.8-2: Content of Resolutions
- 8.8-3: Government Code Compliance
- 8.8-1: AUTHORITY TO IMPOSE AND CHARGE DEVELOPMENT IMPACT FEES: The City Council of the City of Firebaugh is hereby granted authority to establish and charge development impact fees as a condition of approval of a development project for the purpose of defraying the costs of public facilities (including public improvements, public services and community amenities) related to development projects. Development impact fees may be established and charged to pay for the cost of development of streets and thoroughfares, law enforcement facilities and equipment, fire facilities and equipment, general city facilities, wastewater collection facilities, water supply and holding facilities, water distribution facilities, and parks and recreation facilities.
- 8.8-2: **CONTENT OF RESOLUTIONS:** In enacting resolutions establishing and imposing such impact fees, the City Council shall set forth the specific amount of the fee, describe the benefit and impact area on which the development impact fee is imposed, list the specific public improvements to be financed, describe the estimated cost of facilities, describe the reasonable relationship between the fees and the various types of developments, and set forth the time for payment. The City Council may further provide in such resolution that specific limitations will apply to reductions, adjustments, waivers, or deferrals of development impact fees and the City Council may, in such resolution, set forth such specific limitations.
- 8.8-3: **GOVERNMENT CODE COMPLIANCE:** Such resolutions shall be adopted in accordance with the provisions of chapter 5 of division 1 of title 7 of the California Government Code (commencing with section 66000)."
- SECTION 2: This Ordinance shall take effect sixty (60) days after its adoption and before the expiration of fifteen (15) days after its adoption shall be published once in a newspaper of general circulation, published in the City of Firebaugh.

#### **RESOLUTION NO. 16-25**

### A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH ESTABLISHING AND IMPOSING IMPACT FEES FOR DEVELOPMENT PROJECTS

WHEREAS, by Ordinance No. 16-02, adopted on August \_\_\_\_\_\_, 2016, the City Council (the "City Council") of the City of Firebaugh (the "City") granted authority to establish and charge development and impact fees as a condition of approval of development projects for the purpose of defraying the costs of public facilities (including public improvements, public services and community amenities) related to development projects; and

WHEREAS, pursuant to the State Mitigation Fee Act (Government Code Sections 66000 et. seq.) such development impact fees may be established and charged to pay for the cost of development of public facilities, including but not limited to streets and thoroughfares, law enforcement facilities and equipment, fire facilities and equipment, general City facilities, storm drainage facilities, wastewater treatment facilities, wastewater collection facilities, water supply and holding facilities, water distribution facilities, and parks and recreation facilities; and

WHEREAS, in Ordinance No. 16-02, the City Council provided both that in enacting resolutions establishing and imposing such impact fees the City Council shall set forth the specific amount of the fee, describe the benefit and impact areas on which the development impact fee is imposed, list the specific public improvements to be financed, describe the estimated cost of the facilities, describe the reasonable relationship between the fees and the various types of developments, and set forth the time for payment, and that the City Council may further provide in such resolution that specific limitations will apply to reductions, adjustments, waivers, or deferrals of development impact fees and further that the City Council may, in such resolution, set forth such specific limitations; and

WHEREAS, David Taussig & Associates has prepared a report dated May 26, 2016, (Report) which analyzes the impacts of contemplated future development on existing public facilities in the City, along with an analysis of the need for new public facilities and improvements required by new development, and said Report sets forth the relationship between new development, the needed facilities and their estimated costs; and

WHEREAS, City Staff has reviewed the service provisions and development impact cost portions of said Report, thereby independently verifying and validating said Report; and

WHEREAS, the aforesaid David Taussig & Associates (as well as all material supplementary thereto, and all background data referenced in the Report), and a copy of Ordinance 16-02 were available for public inspection and review at the City Clerk's office of the City for a period of at least ten (10) days prior to the public hearings on this resolution, the Report and the impact fees; and mailed notice was given at least fourteen (14) days prior to said hearing to any interested person who filed a written request (if any) with the City for mailed notice of the public hearing; and

WHEREAS, said public hearing was also noticed pursuant to and in compliance with Government Code Section 6062a, and was held as part of a regularly scheduled meeting of the City Council; and

WHEREAS, said public hearing on adoption of this resolution, the Report and the impact fees referred to by the Firebaugh City Council will hold a public hearing at 1655 13th St., Firebaugh, California on Monday, July 18, 2016 at 6:00 pm, at which all interested were given an opportunity to be heard; and

WHEREAS, the City Council has duly considered all oral and written testimony presented at or prior to the hearing a Public. This resolution and staff report has been available for review at City Hall, 1133 P St, Firebaugh, CA 93622 and/or considered all received call (559) 659-2043 from 8am-4pm.

**NOW THEREFORE,** in accordance with the provisions of Ordinance No. 16-02 and Government Code Sections 66000, et. seq., and based on all the evidence in the record, the City Council of the City of Firebaugh resolves, finds and determines as follows:

- 1. All provisions set forth above are true and correct and are hereby incorporated herein by reference as findings. The David Taussig & Associates Report incorporated herein by reference.
- 2. The purpose of the fees set forth herein is to finance expanded or new public facilities to reduce the impacts on public facilities caused by new development.
- 3. The City Council hereby adopts and approves the previously mentioned David Taussig & Associates Report, following the public hearing on the matter and the same is incorporated herein, and the City Council further finds that new development in the City will generate additional demands on public facilities throughout the City, and will contribute to the impact upon public facilities.
- 4. Establishing and imposing updated development impact fees as described in the David Taussig & Associates Report is necessary and proper to defray the cost of development of public facilities related to development projects, including without limitation, streets and thoroughfares, law enforcement facilities and equipment, fire facilities and equipment, general City facilities, storm drainage facilities, wastewater treatment facilities, wastewater collection facilities, water supply and holding facilities, water distribution facilities, and parks and recreation facilities in and for the City.
- 5. The specific amount of each updated development impact fee, the description of all the benefit and impact area on which each development impact fee is imposed, the listing of the specific public improvements to be financed by each such fee, the description of the estimated cost of the facilities, the description of the reasonable relationship between the fees and the various types of developments, and the time for payment set forth in the David Taussig & Associates Report and below in this resolution on which they will be imposed, are proper and necessary and, as all the information and data upon which the fees are based is correct and accurate.
- 6. The specific amount of development impact fees are hereby updated, modified and imposed and are based upon the impact costs by land use as set forth in the table below:

- 7. The benefit and impact areas on which the development impact fees are imposed are as described in the Report and annexations to the City after the adoption of said documents. The amount of each fee specified in Paragraph 6 does not exceed the reasonable cost of providing the public facility for which the fee is imposed.
- 8. That facts and evidence in the record also establish that there is a reasonable relationship between the need for the described public facilities and the impacts of the types of development described hereinabove, for which the corresponding fee is charged, and also, there is a reasonable relationship between the fee's use and the type of development for which the fee is charged, as these reasonable relationships or nexuses are in more detail described in the David Taussig & Associates Report.
- 9. Payment of the impact fees established and imposed by this resolution shall be made at the time of issuance of a building permit for any work of improvement, or at such earlier date as allowed by State law, provided, however, that an applicant for a building permit for a residential development may request that payment be deferred until the date of final inspection or the date the certificate of occupancy is issued, whichever occurs first. Said request shall be approved when the property owner signs a contract, approved by the City Attorney, relating to the payment of the deferred fees. The contract shall be recorded on the title to the subject property, shall be a lien on such property, and shall be binding on the owner and all successors in interest to the property.
- 10. The fees set forth herein are consistent with the City's General Plan and the City Council has considered the effects of the fees with respect to the City's housing needs (as established in the Housing Element of the General Plan) and the regional housing needs.
- Pursuant to California Government Code Section 66017, the fees adopted and approved by this resolution shall be in full force and effect and shall be collected beginning sixty (60) days from and after its adoption, and shall further, apply to any developments heretofore approved by the City Planning Commission or City Council.

#### **ORDINANCE NO. 16-03**

#### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH AMENDING CHAPTER 22.5 OF THE FIREBAUGH MUNICIPAL CODE TO IMPOSE A 5% UTILITY USERS TAX ON WIRELESS TELECOMMUNICATION SERVICES

The City Council of the City of Firebaugh does hereby ordain as follows:

**Section 1.** That section 22.5-1 of the Firebaugh Municipal Code, entitled "Definitions," is amended to add a new subsection "j." to read as follows:

"i. 'Telephone communication services' shall mean and include the transmission, conveyance, or routing of voice, data, audio, video, or any other information or signals to a point, or between or among points, whether or not such information is transmitted through interconnected service with the public switched network, whatever the technology used, whether such transmission, conveyance or routing occurs by wire, cable, fiber-optic, light wave, laser, microwave, radio wave (including, but not limited to, cellular service, commercial mobile service, al communications service (PCS), specialized mobile radio (SMR), and other types of al wireless service--see 47 USCA § 332(e)(7)(C)(i)----regardless of radio spectrum used), switching facilities, satellite or any other technology now existing or developed after the adoption of the ordinance codified in this chapter, and includes, without limitation, fiber optic, coaxial cable, and wireless. The term 'telephone communication services' includes such transmission, conveyance, or routing in which computer processing applications are used to act on the form, code or protocol of the content for purposes of transmission, conveyance or routing without regard to whether such services are referred to as voice over internet protocol (VoIP) services or are classified by the Federal Communications Commission as enhanced or value added, and includes video and/or data services that are functionally integrated with telecommunications services. 'Telephone communication services' include, but are not limited to, the following services regardless of the manner or basis on which such services are calculated or billed: central office and custom calling features (including but not limited to call waiting, call forwarding, caller identification and three-way calling), local number portability, text messaging, ancillary telecommunication services, prepaid and post-paid telecommunications services (including but not limited to prepaid calling cards); mobile telecommunications service; private telecommunication service; paging service; 800 service (or any other toll-free numbers designated by the Federal Communications Commission); and value-added non-voice data service. For purposes of this section, 'private telecommunication service' means any dedicated telephone communications service that entities a user to exclusive or priority use of communications channels. 'Telephone communication service' does not include: internet access services to the extent they are exempt from taxation under the Internet Tax Freedom Act, 47 U.S.C. 151 note; video programming services; and digital downloads, such as downloads of books, music, ringtones, games and similar digital products."

**Section 2.** That section 22.5-1 of the Firebaugh Municipal Code, entitled "Definitions," is amended to add a new subsection "k." to read as follows:

"k. 'Ancillary telephone communication services' shall mean services that are associated with or incidental to the provision, use or enjoyment of telephone communication services including, but not limited to, the following:

- 1. Services that link two or more participants of an audio or video conference call, including the provision of a telephone number.
- 2. Services that separately state information pertaining to individual calls on a customer's billing statement
- 3. Services that provide telephone number information, and/or address information.

- 4. Services offered in connection with one or more telephone communications services, which offer advanced calling features that allow customers to identify callers and to manage multiple calls and call connections.
- 5. Services that enable customers to store, send or receive recorded messages."

#### Section 3. That section 22.5-3A is added to Firebaugh Municipal Code, entitled to read as follows:

#### "22.5-3A Wireless Communication users' tax.

- a. This section shall not apply to services subject to tax under section 22.5-3 and is not intended to create a double tax on any telephone services. With regard to rate payers and services not subject to tax pursuant to section 22.5-3, there is hereby imposed a tax upon every rate payer other than a telephone corporation who uses any international, interstate and/or intrastate telephone communication services in the City. Interstate calls shall include calls to and from the District of Columbia or any U.S. territory. The tax imposed by this section shall be at the rate of five percent (5%) of the charges made for such telephone communication services. The telephone communication services supplier or its billing agent shall collect the tax from the service user. To the extent allowed by federal and state law, the tax on telephone communication services is intended to, and does, apply to all charges within the city's tax jurisdiction, such as charges billed to a telephone account having a situs in the city as permitted by the Mobile Telecommunications Sourcing Act of 2000, 4 U.S.C. § 116 et seq. There are rebuttable presumptions that telephone communication services billed to a billing or service address in the city are used, in whole or in part, within the city's boundaries, and those such services are subject to taxation under this chapter. There is also a rebuttable presumption that telephone communication services sold within the city that are not billed to a billing address or provided to a primary physical location are used, in whole or in part, within the city's boundaries and that such services are subject to taxation under this chapter.
  - b. The following shall be exempt from the tax imposed by this section:
    - 1. Charges for services paid for by inserting coins in coin-operated telephones; except that where such coin-operated telephone service is furnished for a guaranteed amount, the amounts paid under such guarantee, plus any fixed monthly or other periodic charge shall be included in the base for computing the amount of tax due; nor shall the term "telephone communication services" include land mobile services or maritime mobile services as defined in § 2.1 of Title 47 of the Code of Federal Regulations, as such section existed on October 1, 1967.
- c. The tax on telephone communication services imposed by this section shall be collected from the service user by the service supplier. The amount of tax collected in one month shall be remitted to the tax administrator on or before the last day of the following month; and must be received by the tax administrator on or before that date.
- d. As used in this section, the term "charges" shall include the value of any other services, credits, property of every kind or nature, or other consideration provided by the service user in exchange for the telephone communication services if a non-taxable service and a taxable service are billed together under a single charge, the entire charge shall be deemed taxable unless the service supplier identifies non-taxable charges by verifiable data reflected in its books and records that are kept in the regular course of business and consistently with generally accepted accounting principles. The service supplier has the burden of proving the proper apportionment of taxable and non-taxable charges.
- e. As used in this section, the term "charges" shall not include charges for any type of service or equipment furnished by a service supplier subject to public utility regulation during any period in which the same or similar services or equipment are also available for sale or lease from s other than a service supplier subject to public utility regulation.

- f. To prevent actual multi-jurisdictional taxation of telephone communication services subject to tax under this section, any service user, upon proof to the tax administrator that the service user has previously paid the same tax in another American jurisdiction on such telephone communication services, shall be allowed a credit against the tax imposed to the extent of the amount of such tax legally imposed in such other American jurisdiction; provided, however, the amount of credit shall not exceed the tax owed to the city under this section.
- g. The tax administrator may, from time to time, issue and disseminate to telephone communication service suppliers, which are subject to the tax collection requirements of this chapter administrative determinations identifying those telephone communication services that are subject to the tax of subsection (a) above. The administrative determinations shall implement the intent of the city council that the telephone users' tax be imposed on any rate payer who initiates or receives high-quality voice communications without regard to the type or kind of transmission media or technology that exists on the date the amendments to this section became effective or which may be developed in the future. Such administrative rulings shall be consistent with legal nexus and laws pertaining to telephone communications services and shall not impose a new tax, revise an existing tax methodology, or increase an existing tax, except as allowed by California Government Code § 53750(h)(2) and (h)(3) or other law. The tax administrator may consider statewide interpretive rules and guidelines promulgated by any government agency or association of government agencies as a factor in determining the intent of voters adopting this section. To the extent that the tax administrator determines that the tax imposed under this section shall not be collected in full for any period of time, such an administrative determination falls within the tax administrator's discretion to settle disputes. The tax administrator's exercise of discretion, under this chapter does not constitute a change in taxing methodology for purposes of Government Code § 53750(h), and the city does not waive or abrogate its right to collect the telephone users' tax in full as a result of issuing such administrative determinations and may suspend such determination and recommence collection of the tax without additional voter approval. The administrative determination shall be consistent with and shall not impose a new tax or increase an existing tax without voter approval.
  - h.1.For purposes of imposing a tax or establishing a duty to collect and remit a tax under this section, "substantial nexus" and "minimum contacts" shall be construed broadly in favor of the imposition, collection and/or remittance of the utility users tax to the fullest extent permitted by state and federal law, and as that law may change from time to time. Any telephone communication service (including VoIP) used by a with a service address in the city, which service is capable of terminating a call to another on the general telephone network, shall be subject to a rebuttable presumption that "substantial nexus" exists or "minimum contacts" exist for purposes of imposing a tax or establishing a duty to collect and remit a tax under this chapter.
  - 2. A service supplier shall be deemed to have sufficient activity in the city to be obligated to collect and remit the tax imposed by this chapter if it does any of the following: maintains or has within the city, directly or through an agent or subsidiary, a place of business of any nature; solicits business in the city by employees, independent contractors, resellers, agents or other representatives; solicits business in the city by means of advertising that is broadcast or relayed from a transmitter within the city or distributed from a location within the city; or advertises in newspapers or other periodicals printed and published within the city or through materials distributed in the city by means other than the United States mail.

Section 4. That section 22.5-14 is added to Firebaugh Municipal Code, entitled to read as follows:

"22.5-14 Effect of state and federal authorization.

To the extent that the city's authorization to impose or collect any tax imposed under this chapter is expanded or limited as a result of changes in state or federal law, no amendment or modification of this chapter shall be required to conform the tax to those changes, and the tax shall be imposed and collected to the full extent of the city's authorization up to the full amount of the tax imposed under this chapter."

#### Section 5. Amendment of Ordinance.

Chapter 22.5 of the Firebaugh Municipal Code as amended by this Ordinance may be repealed or amended by the City Council without a vote of the people except as follows: as required by Proposition 218, any amendment to that chapter that increases the amount or rate of tax beyond the levels authorized by this Ordinance may not take effect unless approved by a vote of the people. The City Council may impose the taxes authorized by that chapter in any amount or rate which does not exceed the rate approved by the voters of the City.

#### Section 6. Severability.

If any section, sentence, clause, phrase, or portion of this Ordinance is held to be invalid or unenforceable by a court of competent jurisdiction for any reason, the remaining sections, sentences, clauses, phrases, or portions of this ordinance shall nonetheless remain in full force and effect. The People of the City of Firebaugh hereby declare that they would have adopted each section, sentence, clause, phrase, or portion of this Ordinance, irrespective of the fact that any one or more sections, sentences, clauses, phrases, or portions of this Ordinance be declared invalid or unenforceable and, to that end, the provisions of this Ordinance are severable.

#### Section 7. Majority Approval; Effective Date; Execution.

This Ordinance shall be effective only if approved by a majority of the voters voting thereon and shall go into effect ten (10) days after the vote is declared by the City Council. The City Clerk is hereby authorized to attest to the adoption of this Ordinance where indicated below.

# RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH ORDERING A MEASURE ON THE ELECTION BALLOT, REQUESTING COUNTY ELECTIONS TO CONDUCT THE ELECTION, AND REQUESTING CONSOLIDATION OF THE ELECTION

WHEREAS, pursuant to Elections Code Section 10002, the governing body of any city or district may by resolution request the Board of Supervisors of the county to permit the county elections official to render specified services to the city or district relating to the conduct of an election; and

WHEREAS, the resolution of the governing body of the city or district shall specify the services requested; and

WHEREAS, pursuant to Elections Code Section 10002, the city or district shall reimburse the county in full for the services performed upon presentation of a bill to the city or district; and

WHEREAS, pursuant to Elections Code Section 10400, whenever two or more elections, including bond elections, of any legislative or congressional district, public district, city, county, or other political subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated upon the order of the governing body or bodies or officer or officers calling the elections; and

WHEREAS, pursuant to Elections Code Section 10400, such election for cities and special districts may be either completely or partially consolidated; and

WHEREAS, pursuant to Elections Code Section 10403, whenever an election called by a district, city or other political subdivision for the submission of any question, proposition, or office to be filled is to be consolidated with a statewide election, and the question, proposition, or office to be filled is to appear upon the same ballot as that provided for that statewide election, the district, city or other political subdivision shall, at least 88 days prior to the date of the election, file with the board of supervisors, and a copy with the elections official, a resolution of its governing board requesting the consolidation, and setting forth the exact form of any question, proposition, or office to be voted upon at the election, as it is to appear on the ballot. Upon such request, the Board of Supervisors may order the consolidation; and

WHEREAS, the resolution requesting the consolidation shall be adopted and filed at the same time as the adoption of the ordinance, resolution, or order calling the election; and

WHEREAS, various district, county, state and other political subdivision elections may be or have been called to be held on November 8, 2016; and

WHEREAS, the City desires to adopt Ordinance No. 16-03 to impose a 5% utility user's tax on wireless telecommunication services, subject to a simple majority (50% plus 1) voter approval, as required by Cal. Const., art. XIIIC, § 2(b); and

WHEREAS, by Resolution 16-26, the City Council declared by unanimous vote that a fiscal emergency exists in the City of Firebaugh pursuant to Article XIII C § 2(b) of the California Constitution which requires an election to approve a tax to be consolidated with a regularly scheduled general election for members of the governing body of the local government, except in cases of emergency declared by a unanimous vote of the governing body; and

WHEREAS, the City Attorney shall prepare an impartial analysis of the Measure.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the governing body of the City of Firebaugh hereby orders a traditional General election be called and consolidated with any and all elections also called to be held on November 3, 2016 insofar as said elections are to be held in the same territory or in territory that is in part the same as the territory of the County of Fresno, requests the Board of Supervisors of the County of Fresno to order such consolidation under Elections Code Section 10401 and

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH CONFIRMING THE DIAGRAM AND ASSESSMENT OF ANNUAL LEVY FOR FISCAL YEAR 2016-2017 FOR LANDSCAPING AND LIGHTING DISTRICT NO. 1

WHEREAS, pursuant to the Landscaping and Lighting Act of 1972 (Streets & Highways Code ' 22500 et seq.) (the "Act"), the City Council of the City of Firebaugh declared its intention to form, conducted all proceedings to form and did form Landscaping and Lighting Maintenance District No. 1 of the City of Firebaugh (the "District"), and has thereafter levied and collected the first assessment and subsequent annual assessments for maintenance and operation of landscaping, street lighting and other permanent improvements which constitute a portion of the public street, sidewalk and drainage systems within the District (collectively, the "Improvements") and which provide direct special benefits to the various parcels assessed over and above benefits conferred on the public at large; and

WHEREAS, the City Engineer has prepared and filed with the City Clerk a report entitled "Engineer's Report of the City of Firebaugh Landscape and Lighting Maintenance District No. 1, 2016-2017," dated June 20, 2016 (the "Annual Levy Report"), to which reference is hereby made, which Annual Levy Report contains a description of the existing Improvements in the District, the boundaries of the District and any zones therein, and the general location and proposed assessments on the assessable lots and parcels of land within the District; and

WHEREAS, the City Engineer also has prepared and filed with the City Clerk maps of the boundaries of the District; and

WHEREAS, on June 20, 2016, the City Council adopted Resolution No. 16-22, "A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH TO LEVY AND COLLECT THE ANNUAL ASSESSMENTS DISTRICT NO. 1 (*Pursuant to the Landscaping and Lighting Act of 1972*), whereby the City Council declared its intention to levy and collect the annual assessments for operation and maintenance of the Improvements within the District for the 2016-2017 fiscal year; and

WHEREAS, the amount of the assessments proposed in the Annual Levy Report for the 2016-2017 fiscal year, except those assessments on the lots and parcels of land within Zone A (Tract No. 5529), are the same or less than the amount of the District assessments in all previous fiscal years; and

WHEREAS, the assessments on the lots and parcels within Zone A (Tract No. 5529) were proposed to increase by the change in the Consumer Price Index-U for the San Francisco Bay area as of December 2007 (the "CPI") over the December 2007 base year CPI, not to exceed three percent, as previously approved by a majority vote of the owners of the lots and parcels in Zone A voting in a land owner ballot proceeding on the issue of the assessment conducted on August 6, 2007, in accordance with Article XIIID of the California Constitution and Section 53753 of the California Government Code; therefore, the proposed assessments on the lots and parcels in Zone A for fiscal year 2016-2017 are not deemed increased for purpose of these proposed annual assessment proceedings; and

WHEREAS, the proceeds of the assessments to be levied on the lots and parcels in the District will be used exclusively to finance the expenses for operation and maintenance of the Improvements for the 2016-2017 fiscal year, which operation and maintenance will provide direct special benefits to the various lots and parcels in the District, over and above the benefits conferred on the public at large; and

WHEREAS, the amount of the assessment on each lot or parcel in the District is proportional to and no greater than the special benefits conferred on such lot or parcel from operation and maintenance of the Improvements described in the Annual Levy Report; and

WHEREAS, after notice by publication of the Resolution of Intention as required by the Act, the City Council conducted a public hearing and heard and considered all objections and protests to proposed assessments on all lots and parcels within the District for fiscal year 2016-2017;

**THEREFORE**, the City Council of the City of Firebaugh resolves finds and determines as follows:

- 1. The recitals, findings and determinations in the Resolution of Intention are hereby restated and confirmed. The recitals in the Resolution of Intention and in this resolution, above, are true and correct.
  - 2. The map of the boundaries of the District, prepared by the City Engineer, is hereby approved.
- 3. The territories within the District, whose boundaries are set forth in the Annual Levy Report, are the territories directly and specially benefited, over and above the benefits conferred on the public at large, from operation and maintenance of the Improvements described in the Annual Levy Report.
- 4. The hearing on the annual levy of assessments in the District for fiscal year 2016-2017 was noticed and held in accordance with law.
- 5. The Annual Levy Report, including the diagram of the District and the assessment of the estimated costs of operation and maintenance of the Improvements contained in the Annual Levy Report, and each and every part of the Annual Levy Report, are finally adopted, confirmed and approved.
- 6. The assessment diagram showing the District and the lots and parcels of land within the District, all as contained in the Annual Levy Report, is finally approved and confirmed as the diagram of the lots and parcels within the District to be assessed to pay the costs of operation and maintenance of the Improvements described in the Annual Levy Report.
- 7. The assessment of the total amount of the costs and the individual assessments thereof on the lots and parcels within the District, in proportion to the direct special benefits to be conferred on each such lot or parcel from operation and maintenance of the Improvements, and of the expenses incidental thereto, as set forth in the Annual Levy Report, is finally approved and confirmed as the annual assessment for the 2016-2017 fiscal year to pay such costs.
- 8. The levy of the annual assessments within the District for fiscal year 2016-2017, as described in the Resolution of Intention and the Annual Levy Report, is hereby ordered.
- 9. The City Clerk is authorized and directed to file the diagram of the District and assessments therein, as approved and confirmed by the Council, with the Fresno County Auditor-Controller Treasurer-Tax Collector immediately after adoption of this resolution.
  - 10. This resolution shall take effect immediately upon adoption.

#### 6-4 VICIOUS DOGS.

## 6-4.1 Vicious Dog Defined.

Any dog, except one assisting a peace officer engaged in law enforcement duties, which demonstrates any of the following behavior, is presumed vicious:

- a. An attack, which requires a defensive action by any person to prevent bodily injury or property damage when such person is conducting himself or herself peacefully and lawfully.
- b. An attack, which results in property damage or in an injury to a person when such a person is conducting himself or herself peacefully and lawfully.
- d. Any behavior, which constitutes a threat of bodily harm to a person when such a person is conducting himself or herself peacefully and lawfully.
   (Ord. #87-9, S1)

## 6-4.2 Investigation.

Any incident reported to the Firebaugh Police Department concerning a vicious dog may be investigated by the chief of police, or his designee. If, based on the investigation, the chief of police concludes that there is probable cause to believe that the dog is vicious, he shall so certify in writing to the person owning or controlling the dog within ten (10) days following completion of the investigation. Thereafter a hearing shall be held pursuant to subsections 6-4.4, 6-4.5 and 6-4.6 below. (Ord. #87-9, S1)

## 6-4.6 Hearing-Findings; Public Nuisance.

- a. If, after the hearing, or the report of the hearing officer, the city manager upholds the findings of the chief of police that the dog is vicious, he or she shall so specify in writing together with the reasons therefor. Any dog found to be vicious is hereby deemed to be a public nuisance and shall be, pursuant to the order of the city manager, humanely destroyed, removed from the city, or be otherwise abated by appropriate order of the city manager, including, but not limited to, those conditions specified in paragraph b. of this subsection 6-4.6.
- b. Without limiting the city manager's authority under paragraph (a), the city manager may order a dog determined to be vicious to be released to the owner or other person responsible for controlling the dog subject to such conditions as the city manager deems necessary to abate the vicious dog, including but not limited to any or all of the following:
  - 1. Leash and muzzle. No person shall permit a vicious dog to go outside its kennel or pen unless such dog is securely leashed with a leash no longer than four (4) feet in length. No person shall permit a vicious dog to be kept on a chain, rope or other type of leash outside its kennel or pen unless a person is in physical control of the leash. A vicious dog on a leash outside its kennel or pen, must be muzzled by a muzzling device, sufficient to prevent such dog from biting persons or other animals.
  - 2. Confinement. A vicious dog shall be kept securely confined indoors or in a securely enclosed and locked pen, kennel or other structure, except when leashed and muzzled as above provided.
  - 7. Reporting. The owner, keeper or harborer of a vicious dog shall, within ten (10) days after the following incidents, report the following information in writing to the chief of police or his designee:
    - (a) Death or removal from the city of the dog;
    - (b) The new address of the dog owner, keeper or harborer, if such owner, keeper or harborer moves within the city limits;

If the city manager orders such conditional release, no person shall keep, possess, maintain or harbor within the city limits the dog covered by the order, except in full compliance with all conditions stated in the order. (Ord. #87-9, S1; Ord. #01-05, S3)

#### 6-4.7 Appeals.

The city council shall hold a hearing on the appeal at its regularly scheduled meeting first occurring after the filing of the notice of appeal. The city council shall consider only the evidence received by the city manager, and may affirm, reverse or modify the order of the city manager. No new evidence shall be received. The decision of the city council shall be final. (Ord. #87-9, S1)

## **Narrative**

## SOURCE:

On Friday, May 13th, 2016, at approximately 2031, I was on patrol in full uniform and operating a marked Firebaugh Police Department patrol vehicle. On this date and time, I was dispatched to 1544 N St Space #106, in regards to male individual reporting that a dog had just bitten his son.

## **INVESTIGATION:**

I arrived on scene approximately one (1) minute from the time I was made aware of the incident in question. Upon arrival, I was flagged down by a male individual, who identified himself as the reporting party in this matter. The male individual quickly directed me towards his son. I was able to observe the young boy who was sobbing. At this time, I estimated him to be approximately ten (10) years of age. The young boy proceeded to lift his shirt and show me his back. At this point, I was able to locate a small laceration approximately two (2) inches in diameter on the center of his back. The wound was red but was not bleeding. It was apparent that the skin had been broken. Given the severity of the injury, which the boy sustained, I proceeded to advised dispatch to advise Fire and EMS to reduce to code 2. Firebaugh Fire Department arrived on scene approximately two (2) minutes after I did. Upon their arrival, they quickly advised dispatch to cancel EMS. Firebaugh Fire proceeded to tend to the young boys injuries. At this time, I proceeded to locate a witness.

## **WITNESS STATEMENT:**

A female who identified herself by her State issued California Driver's License and proceeded to recount what events had transpired which subsequently lead to the young boy being bitten by the dog. She stated that one of the dog's multiple owners frequently taunts some of the young children who live in the area. She stated that he normally does this for his own personal entertainment. She advised that during today's incident, the victim in this matter saw the dog. Upon observing the dog, he ran away from it. The young boy in making this motion got the attention of the suspected dog which ultimate chased after him. The dog caught up to the fleeing boy and bit his back. The Female, stated that she observed the owner of the dog standing near it initially, and once the dog took off in pursuit, the owner made no attempt to stop the dog. The individual then, stated that the dog was at no point on a leash and frequently roams the neighborhood.

## **INVESTIGATION:**

I proceeded to make contact with the owner who identified herself as Maria Rios-Ortiz, DOB: 02-08-1977. She stated that she observed the entire incident. In obtaining her statement, it was determined that it was consistent with the information provided by the reporting individual, the witness in this matter. Rios-Ortiz stated that she believed the reason her dog attacked the victim, was due to him constantly teasing it, whenever the dog is chained up. I concluded by obtaining her personal information for the completion of the report. She was subsequently advised that her dog was going to be picked-up and quarantined. She cooperated fully with the investigation of the case.

I continued by making contact with the now treated young boy who identified himself. He appeared to be in good spirits after being checked and cleared by Firebaugh Fire. I also made contact with his father who identified himself by his state issued California Driver's License. I was able to obtain all the necessary information for the completion of the report.

Upon completion of my investigation, I returned to Rios-Ortiz and advised her that I was going to be issuing her a Firebaugh Police Department Citation for violations of FMC 6-1.3 owners duty to control dog, and FMC 6-4.1(b) Vicious Dog. Her citation was mailed.

The rabies control report from was completed and faxed to the Fresno County Department of Public Health, Environmental health Division (see attached).

The evidence presented such as photos, testimony and my research leads me to hereby declare the dog vicious, which constitutes a public nuisance.

My decision can be appealed to the city council by filing a notice of appeal with the City Clerk within ten (10) days of the above date.

## **Violations**

#### 6-1 LICENSING AND REGULATION OF DOGS.

#### 6-1.2 Licensing of Dogs.

- a. License requirement and fees. The owner or custodian of any dog over the age of four (4) months shall procure a city dog license and pay therefor an annual license fee as established by resolution of the city council for each dog which is not spayed or neutered and an annual license fee as established by resolution of the city council for each dog which is spayed or neutered. The license fee shall be due and payable on January 1 or July 1 annually. The amount of such license shall be paid to the city clerk and upon payment thereof, the city clerk shall issue a metal tag with the number and year of the issuance thereof and the words "City of Firebaugh" plainly inscribed thereon, and shall enter in a register kept by him for that purpose the name and address of the owner of the dog licensed or the person to whom such license is issued, a description of such dog, the number of the tag, and the date of its issuance. Duplicate metal tags may be issued upon payment as established by resolution of the city council for each duplicate tag so issued. Any person failing to procure and pay for such license within thirty (30) days of the date when it is due shall pay an additional fee as established by resolution of the city council as a penalty for such delinquency.
- b. Proof of neutering or spaying. Before a city dog license may be issued for the lower annual license fee for a dog which has been spayed or neutered, the owner or custodian of such dog shall provide evidence that the dog has been spayed or neutered. Such evidence shall be a certificate signed by a doctor of veterinary medicine, on his letterhead stationery.
- c. Attachment of tags. The dog license tag issued to any person upon the payment of the license fee herein provided shall be securely attached to a collar or harness on such dog; provided, however, that such tag need not be attached to any dog in the dwelling house of the owner or custodian or in an enclosed yard adjacent thereto. The pound master shall impound any dog not on the premises of the owner and not bearing a dog license tag from the city.

## 6-1.3 Owner's Duty to Control Dogs.

- a. Dogs at large. It shall be unlawful for any person owning or having charge of, care of, or control of any dog to permit or allow the same to run at large within the city upon any street, or other public place, or upon any private property without the consent of the owner thereof.
- b. Leash requirement. It shall be unlawful for any person owning or having charge of, care of or control of any dog to permit or allow same to be within the city upon any street, or other public place, or upon any private property, without the consent of the owner thereof, unless the dog is upon and secured to a cord, chain or leash and the length of such cord, chain or leash is no more than eight (8) feet in length, and the end thereof is secured to a person.
- c. Restraint of females. It is unlawful for the owner of any female dog to cause to permit the same to stray or run at large off the premises of the owner or in any public place while in heat, and it shall be the duty of any officer to take up and impound such female dog whether licensed or unlicensed which is found running at large in violation of this section. The dog may be redeemed only after the expiration of a period of ten (10) days from the date of such impounding and then only upon the payment of a redemption fee of ten (\$10.00) dollars.

#### 6-5 VACCINATION OF DOGS.

## 6-5.1 Annual Vaccination Required.

It shall be unlawful for any person owning, having an interest in, harboring, or having the care, charge, custody, or possession of a dog to allow or permit such dog to go on the public streets in any manner, or to go free and run at large in or upon any place in the city, unless such dog has been vaccinated with canine rabies vaccine - one injection or approved method - within a period of twelve (12) months. This vaccination shall be performed by a licensed veterinarian approved by the board of health. The persons vaccinating the dog shall issue certificates of vaccination on blanks furnished by the city. (Ord. #355, S7)

## **BACKGROUND**

The major work consists of constructing approximately 1,500 linear feet of asphalt concrete trail, trailhead facilities, 1,400 linear feet of sidewalk, and miscellaneous concrete improvement at various locations in the City of Firebaugh.

The project was advertised on June 1, 2016, June 8, 2016, and June 15, 2016, and bids were opened July 6, 2016.

## DISCUSSION
