RESOLUTION NO. 20-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH APPROVING CITY PARTICIPATION IN THE STATE OF CALIFORNIA GREAT PLATES DELIVERED PROGRAM AND AUTHORIZING THE CITY MANAGER TO ADMINISTER THE PROGRAM FOR THE CITY

WHEREAS, on May 7, 2020, the State of California published the Great Plates Delivered Program ("Program") Guidance which highlights the opportunity for the City of Firebaugh ("City") to have local restaurants provide meals to local seniors and have the costs reimbursed from the FEMA Public Assistance Program; and

WHEREAS, the Program requires a letter of intent be submitted to demonstrate Program interest; and

WHEREAS, the City desires to pursue the Program to provide meals for qualified senior residents and aid local restaurants who are also challenged in this time of COVID-19 mitigation.

NOW THEREFORE, IT IS HEREBY RESOLVED, by the City Council of the City of Firebaugh that:

- 1. The Great Plates Delivered Program is approved for City participation.
- 2. City Manager is authorized to serve as the City's authorized representative and administer the Program details and reporting.
- 3. City Manager shall review the Program and reimbursement process after two weeks of meals are provided and return to the Council with a recommendation on whether to extend the Program in the City.
- 4. Not to exceed \$13,500, for a two (2) week program and twenty (20) qualifying seniors.
