- > Fire Chief, John Borboa Fires incidents are down, but there's an increase in Vehicle accidents.
- ➤ <u>Police Chief, Sal Raygoza</u> Crime rate continues to be low, 357 cases of COVID-19, with only 10 active cases, we are keeping the numbers low, so restaurant are open at 25%, Code Enforcement is doing outreach to the businesses. Mayor Lopez thanked Sal & Staff for doing a great job.
- > City Manager, Ben Gallegos Anita reached out to businesses to see if they need help or assistance with more canopies or barricades, they can provide the items to them, two businesses asked for help. Thank you to those that came out on Friday to the VFW, & thank you to the contractors for their help, no change orders were needed. West Hills College is behind, they asked to extend work hours, so if there are no complaints, they will continue to with extend work hours, but if we receive complaints we will reduce the hours back to normal. A transformer blew out, I heard it was a Mylar balloon that caused it, but not sure if it is true, the TLC board was damaged as a result, all of the guys are trained & can fix it but it will need to be repaired. Council Member Sablan asked what it would cost. City Manager replied, two different companies will look at it to give a quote, estimated cost is about \$3,000 to \$5,000 for parts. Fire Chief confirmed, someone released a bouquet of Mylar balloons which caused the transformer to blow out. Council Member Valdez, added that was one of his concerns, if we should ban mylar balloons in the park areas to avoid other outages. Council Member Sablan asked for an update about the Senior Center. City Manager replied, we still have Anita, FMAAA notified us that they won't renew a contract until next year. I spoke with the school, the city will need the Senior Center back during the election for a two week period. The fall clean-up will be next week. The League of Cities annual conference will be held via webinar this year.
