STAFF REPORTS

- > Mr. Herreman of Congressman Valadao's Office Working hard to get more vaccines in the Valley & to the Public.
- **Bethany Matos, Associate Dean of North District Center** Foundation should be done within the next month. Class schedules for summer, fall & spring session are available online to register, open registration to begin on March 18th. WE will offer ESL classes on Saturday through May, we're work to get e-sports to campus.
- > Mr. Mark Benjamin of Board of Supervisor Brain Pacheco's Office opened new tier for vaccinations to teachers & other groups in hope of opening schools. Mayor stated, some folks are being told to go to Madera for a vaccination shot but isn't it only of available to people living in Madera County. Council Member Sablan heard from several people they are being charged \$100 for the Covid-19 Shot in Mendota, and asked Mr. Benjamin to look in to the matter.
- Finance Director, Pio Martin There is an issue with the utility billing system, so two options is the City sun the bills after the 5th, which is the deadline per ordinance, or mail out the bills with flat rate fee only, then bill the usages on the next monthly bills once the system is repaired.
- > <u>City Attorney James Sanchez</u> will issues memos to the council.
- > <u>City Engineer, Mario Gouveia</u> Project update, projects are going well on the sewer line project, & bids will be held for 8th St Rehab this Wednesday.
- Deputy City Clerk, Rita Lozano Lozano Smith mailed Council new Brown Act books, they have been placed in your mail boxes at City Hall.

- Police Chief, Sal Raygoza Covid cases are continuing to drop, our department will assist Valley Health team to vaccinate farmworkers on the 9th or 11th, it will provide the 2nd vaccine to the individuals that previously received their 1st shot. Crime is down, Our Code Enforcement Seferino was promoted to a Full-time Police Officer Position.
- Eity Manager, Ben Gallegos—"I would like to echo Mario comments", the sewer project is going well, and it will be crossing the intersection, so there will be a lot of detours at the crossing. Bids will be held March 3rd, & the project will have some change orders due to some line we ran into that we were unaware & will be replaced. Some of the lines being replaced were budgeted for, but others weren't so the will be added extra fees for street & line work. I received information that mail wasn't being delivered, but I took pictures & spoke with the post master to explain, I didn't see where or why there's an issue that mail couldn't be delivered, they stated they would get back to me, but I haven't heard from them. VFW has electricity & gas to the building, so they're ahead of schedule but I'm still looking at April for the project to be completed. When it comes to the American Rescue Plan, we might be able to get about \$1.5 million for economic recovery, it was passed at the House of Representatives & now is going before the Senate for approval. Hopefully, they'll vote no later than March 14th, we don't have all of the details on how the money can be spent, but we will researched & provide you with the information once we get it. All Departments (PD, Public Works & Fire) will provide Quarterly reports, as well as, which training employees are attending on a quarterly bases.
- > <u>Council Member Lopez</u> nothing to report, but suggest Council start holding in person Council Meetings.
- <u>Council Member Sablan</u> asked for an update on the cannabis applicants & the status of employees that received their Covid vaccination. City Manager Gallegos replied, the committee is scheduled to have interviews with two of the applicants, one on March 8th & the other on March 9th. None at this time, only Fire & Police department are eligible at this time to get the vaccine.
- > Council Member Perez nothing to report.
- Council Member Jenkins Inquired about an update on working with Cliff. City Manager Gallegos informed, Cliff is no longer working with them, but some individual interested in the land.
- Council Member Valdez Called on Mrs. Matos, who asked can anyone be on the cannabis committee? City Manager Gallegos replied, yes, but there is only five members & all positions are currently filled, if a position becomes vacant, we can notify her to fill the position, if she is still interested.

BACKGROUND

The Assessment District was formed for the purpose of financing maintenance and improvement costs for street lighting, streets, public landscaping and park improvements in the District. The levy of assessments to property owners in the District occur on an annual basis.

In order to meet the timelines required by the Landscaping and Lighting Act of 1972 (herein the "Act") and the Government Code, it is now necessary to initiate proceedings for the annual levy of assessments against all properties in the District. The City Engineer will need to prepare and file a report regarding the annual levy in accordance with Article 4 (commencing with Section 22565) of Chapter 1 of the Act.

Need wording adding Greystone Estates to the annual filing and diagram.

The City has added the subdivisions Greystone Estates and Del Rio Estates to the District over the past year. The annexation for Greystone Estates was approved by the City Council on December 7, 2020 under Resolution No. 20-52. The Del Rio Estates annexation was approved on March 1, 2021 under Resolution No. 21-07. Both annexations were approved for the levy of assessments starting with Fiscal Year 2021-2022.

RECOMMENDATION

Staff recommends that Council approve the attached Resolution Initiating Proceedings for the Annual Levy of Assessments for the Landscaping and Lighting Maintenance District No. 1 and to direct the City Engineer to prepare and file his annual report on the levy.

Re: Discussion Unmanned Aerial System

I am presenting this report to City Council, to introduce the Unmanned Aerial System Program that will be implemented to the police department's specialized units.

Recently, I was approached by Officer Tabares and Reserve Sergeant Ortiz regarding in cooperating a drone program for the department. They explained the benefits the equipment and how it would assist with different aspects of investigations and provided the following examples: assisting in locating crime suspects, building searches, and assist with locating missing persons. They pointed out a recent call, where an at-risk adult had been missing for several days. A team of officers and volunteers went out on ATV's and Gators to search the San Joaquin River. Some of the areas were inaccessible due to high vegetation and muddy waters. They explained that having a drone would have assisted in the search. Unfortunately, the gentleman was located weeks later, in a field not too far out of Firebaugh.

Over the years, police departments across the county have enhanced their specialized units with an Unmanned Aerial System. Drones are typically used by law enforcement in providing an overhead view of an area or incident for ground personnel, safely clearing of the exterior/interior of buildings, providing detailed documentation of crime and accident scenes.

I directed the officers to conduct research into a drone program and how the drone program would be beneficial to both the police department and our community. Sgt. Ortiz submitted his research and presented me with the following information.

THE GOALS OF THE UNMANNED AERIAL SYSTEM PROGRAM ARE AS FOLLOWS:

- To utilize for locating missing children/at-risk adults
- Provide aerial support during natural disasters
- Assisting in locating fleeing suspects
- Safety clearing of buildings
- Assist Fire Department with arial view of fires
- Documenting large crime scenes
- Utilize during Search Warrant Service

FFA GOVERNMENT AGENCY LICENSING:

The operation of the drone system by government agencies require licensing through the FAA. Licensing can be accomplished two different ways:

- FAA Part 107 licensing this license's the individual officers to operate UAVs for government operations. This method of certification is more expensive, approx. \$150 per license.
- FAA Certificate of Authorization (COA) this licensing method authorizes the department to train officers and operate UAVs under the COA, allowing for the training of more officers without additional costs. There is no cost to obtain a COA; however, it can take up to a year to obtain the COA from the FAA.
- Additional waivers are required for night flight, altitude restriction waivers, line of sight operation, flight over crowds, and for operation in the approach areas of airports (Firebaugh's West Side).



Unmanned Aerial System (UAS) Operations

609.1 PURPOSE AND SCOPE

The purpose of this policy is to establish guidelines for the use of an unmanned aerial system (UAS) and for the storage, retrieval and dissemination of images and data captured by the UAS.

609.1.1 DEFINITIONS

Definitions related to this policy include:

Unmanned Aerial System (UAS) - An unmanned aircraft of any type that is capable of sustaining directed flight, whether preprogrammed or remotely controlled (commonly referred to as an unmanned aerial vehicle (UAV)), and all of the supporting or attached systems designed for gathering information through imaging, recording or any other means.

609.2 POLICY

Unmanned aerial systems may be utilized to enhance the [department/office]'s mission of protecting lives and property when other means and resources are not available or are less effective. Any use of a UAS will be in strict accordance with constitutional and privacy rights and Federal Aviation Administration (FAA) regulations.

609.3 PRIVACY

The use of the UAS potentially involves privacy considerations. Absent a warrant or exigent circumstances, operators and observers shall adhere to FAA altitude regulations and shall not intentionally record or transmit images of any location where a person would have a reasonable expectation of privacy (e.g., residence, yard, enclosure). Operators and observers shall take reasonable precautions to avoid inadvertently recording or transmitting images of areas where there is a reasonable expectation of privacy. Reasonable precautions can include, for example, deactivating or turning imaging devices away from such areas or persons during UAS operations.

609.4 PROGRAM COORDINATOR

The Chief of Police will appoint a program coordinator who will be responsible for the management of the UAS program. The program coordinator will ensure that policies and procedures conform to current laws, regulations and best practices and will have the following additional responsibilities:

- Coordinating the FAA Certificate of Waiver or Authorization (COA) application process and ensuring that the COA is current.
- Ensuring that all authorized operators and required observers have completed all required FAA and [department/office]-approved training in the operation, applicable laws, policies and procedures regarding use of the UAS.
- Developing uniform protocol for submission and evaluation of requests to deploy a UAS, including urgent requests made during ongoing or emerging incidents.
 Deployment of a UAS shall require written authorization of the Chief of Police or the authorized designee, depending on the type of mission.

- Developing protocol for conducting criminal investigations involving a UAS, including documentation of time spent monitoring a subject.
- Implementing a system for public notification of UAS deployment.
- Developing an operational protocol governing the deployment and operation of a UAS including, but not limited to, safety oversight, use of visual observers, establishment of lost link procedures and secure communication with air traffic control facilities.
- Developing a protocol for fully documenting all missions.
- Developing a UAS inspection, maintenance and record-keeping protocol to ensure continuing airworthiness of a UAS, up to and including its overhaul or life limits.
- Developing protocols to ensure that all data intended to be used as evidence are
 accessed, maintained, stored and retrieved in a manner that ensures its integrity as
 evidence, including strict adherence to chain of custody requirements. Electronic trails,
 including encryption, authenticity certificates and date and time stamping, shall be
 used as appropriate to preserve individual rights and to ensure the authenticity and
 maintenance of a secure evidentiary chain of custody.
- Developing protocols that ensure retention and purge periods are maintained in accordance with established records retention schedules.
- Facilitating law enforcement access to images and data captured by the UAS.
- Recommending program enhancements, particularly regarding safety and information security.
- Ensuring that established protocols are followed by monitoring and providing periodic reports on the program to the Chief of Police.

609.5 USE OF UAS

Only authorized operators who have completed the required training shall be permitted to operate the UAS.

Use of vision enhancement technology (e.g., thermal and other imaging equipment not generally available to the public) is permissible in viewing areas only where there is no protectable privacy interest or when in compliance with a search warrant or court order. In all other instances, legal counsel should be consulted.

UAS operations should only be conducted during daylight hours and a UAS should not be flown over populated areas without FAA approval.

609.6 PROHIBITED USE

The UAS video surveillance equipment shall not be used:

- To conduct random surveillance activities.
- To target a person based solely on actual or perceived characteristics, such as race, ethnicity, national origin, religion, sex, sexual orientation, gender identity or expression, economic status, age, cultural group, or disability.

- To harass, intimidate, or discriminate against any individual or group.
- To conduct personal business of any type.


The UAS shall not be weaponized.

609.7 RETENTION OF UAS DATA

Data collected by the UAS shall be retained as provided in the established records retention schedule.

Patrol

The Firebaugh Police Department's patrol officers provide prompt response to lifethreatening crimes in progress and responds to all non-emergency calls. The police department provides law enforcement patrol services 24 hours a day, 7 days a week, and 365 days out of the year. Our patrol officers are the most visible members of the police department, and their main function is to protect and serve the residents of Firebaugh. During the 2020 year, the police department was comprised of 10 officers, 1

sergeant and the chief of

police.

Officers respond to calls for service, conduct proactive policing, traffic enforcement, investigations, and work in conjunction with the community to address concerns and reduce crime. Firebaugh officers are expected to conduct their own follow-up investigations and close cases, as we are a small agency and do not have detectives.



The Firebaugh Police Department is committed to pedestrian safety. Patrol Officers are frequently assigned to patrol areas around the schools to ensure traffic laws are being obeyed during the morning and afternoon hours.

Officers work a 4/10 work schedule with three days off. Assignments rotate every three (3) months, and officer can be assigned to work; Day Shift, Swing Shift, or Midnight Shift.

Dispatch

While police officers are the face of the Firebaugh Police Department, the dispatch center is the heart of this department. Dispatchers are the first point of contact with the community in their time of need. Dispatching is demanding work and stressful. There are situations where matter of life or death situations can depend on the quick decisions made by the dispatcher, with limited information provided. Dispatchers must possess emotional control, compassion, strong organizational skills, and excellent

communication skills. Firebaugh dispatchers are responsible to answering two (2) E9-1-1 trunks (lines), four (4) business line calls, the fire department line, dispatch officers, dispatch fire department, call other emergency agencies, process reports/citations for the courts, entering vehicle/firearms/property/missing persons in a computerized system maintained by DOJ (California Law Enforcement Telecommunications System (CLETS)), provide customer service to citizens who come into our police lobby, and dispatching for the City of Mendota Police Department and entering their vehicle/firearms/property/missing persons into CLETS.




Our dispatch center is staffed with a total of 4 full-time and 2 part-time dispatchers who are managed by a Dispatch Supervisor. The dispatch supervisor duties include dispatch scheduling, DOJ/FBI stats, records management, courts and District Attorney liaison person, and annual audits. With changes in law and reporting requirements, the dispatch supervisor will have added duties as we move forward into 2022.

Crime Analysis

The Firebaugh Police Department dispatch supervisor is also the departments acting records manager. She is responsible for reporting to the California Department of Justice (DOJ) monthly Part 1 crime statistics that are utilized in the Federal Bureau of Investigation (FBI) Uniform Crime Report (UCR). Part 1 crimes consist of eight crime offenses which have been deemed serious crimes that occur with regularity in all areas of the country and are likely to be reported to police. These offenses are; criminal homicide, forcible rape, robbery, aggravated assault, burglary, larceny theft, motor vehicle theft, and arson.

The Firebaugh Police Department will be required to report both UCR and NIBRS in 2022 to fulfill FBI and DOJ requirements. This new reporting system will significantly affect and change the statistical categories and figures once the transition occurs. NIBRS is an incident-based reporting system versus the hierarchical crime based UCR system. There are many other reporting requirements coming that will require more time from our Dispatch Supervisor.



Code Enforcement

The Firebaugh Police Department has one part-time reserve officer assigned to conduct code enforcement 24 hours a week. The code enforcement officer's mission is to work in partnership with the residents and businesses, to beautify and maintain a safe and desirable living and working environment in our community. Our goal at the city is to get "voluntary compliance," which means we first attempt to educate residents on violations and provide solutions before resorting to punitive action. The code enforcement works closely with patrol officer who commonly refer observed violations, as they are out on patrol.

Our code enforcement officer is also assigned to assist city staff with animal control. The officer commonly deals with unleashed dogs, strays, injured and deceased animals. In addition, the officer will investigate noisy dog complaints, the inhumane treatment, and hoarding of animals. The officer is also responsible for submitting annual report to the county.

K-9 Program



K-9 Kona has been with the Firebaugh Police Department since October of 2019. Kona is a black and white colored mix, Pit Bull and Border Collie, who specializing in narcotic detection. She weighs in around 45 pounds and although small, she is a non-stop working machine. In April, she will be 3 years old.

In 2020, K-9 Kona was deployed over 32 times. Kona's most notable find occurred while assisting another agency during a search warrant. During the search, she located approximately 1 pound of methamphetamine along with

evidence of narcotic sales.

Officer Monay and K-9 Kona are subject to ongoing odor detection training every month, in order to maintain accuracy and stay current with training standards. With this training, Officer Monay and Kona will continue to improve and better serve the community of Firebaugh.



<u>Tobacco School Resource Officer</u>



The Firebaugh Las Deltas School District applied for a three-year Tobacco Law Enforcement Grant that was approved for funding by the State of California. Officer Rodolfo Tabares was assigned to work with the schools, under this grant.

The primary focus of the officer is to conduct tobacco educational training for students and monitor under-age vaping, smoking, and drug use at all our district schools. The officer will also be responsible for educating our local retailers and provide material regarding

laws and ordinances.

Covid-19 made it difficult for Officer Tabares to conduct student outreach and education. However, he was able to conduct several drive-thru events, where educational materials were provided to students and parents. The officer also assisted the schools with truancy and assisted with computer support for distance learning during Covid-19 lock-down. Officer Tabares also organized a Red Ribbon Contest for Hazel Bailey and Mills School students.

Currently, Officer Tabares is assisting with Tobacco Municipal Code changes and making sure all tobacco retailers are following code regulations.

With Covid-19 restrictions changing and people getting vaccinated, Officer Tabares will be more involved in the schools and conducting outreach with students. He will also conduct educational presentations at apartment complexes concerning our Tobacco Municipal Code and the dangers of smoking/vaping tobacco products.




Reserve Officer Unit

The Firebaugh Police Department Reserve Unit currently has three active reserve officers. The unit has a Reserve Sergeant who works under the direction of the patrol sergeant and the chief of police. The reserve sergeant assists in various assignments in the department such as conducting backgrounds, community presentations, reserve officers scheduling and covering patrol shifts.

The reserve officers work various assignments in the department. We have one reserve officers who work as part-time code enforcement for the city. Reserve Officers typically work functions like event security, prisoner transport, community presentations and patrol shifts when full time officers are on vacation or sick. The reserve unit also plays a vital role in large events in the city such as the annual festival and Christmas Parade.

Without reserve officers, we would not be able to sustain the events throughout the year. Reserve officers are required to volunteer a total of 16 hours per month. The department currently has five reserve officer openings and we several applicants going through the hiring process.

Crime Overview



During the 2020 year, we had 73 drug possession arrests where methamphetamines was found in over 90 percent of cases. The methamphetamine epidemic continues affecting the entire Central Valley and the City of Firebaugh, as well. Officer Molina and Officer Monay have most of the narcotics arrests, in the department, and are commended for their efforts in the drug fight. Both officers are also responsible

for all the narcotic search warrants, served during the 2020 year.

Drunk Drivers (DUI)

Patrol officers are always on the lookout for possible DUI drivers within the city or coming into our city from county roads. During 2020, the department had 48 DUI arrests. Officer Miller, Officer Monay and Officer Molina are the top three DUI arresting officers. It should be noted that in 2020, the department arrested more people for driving under the influence of marijuana than any other year. With the legalization of



marijuana, its expected that we will continue to see a rise of driving under the influence of Marijuana.

Auto Theft

In 2020, we noticed a slight decline in motor vehicle theft. The decline can be attributed to officer's high visibility throughout the city and the incarceration of few known auto thieves. During year, officers arrested several known auto thieves from neighboring cities. In 2019 and 2020, western Fresno County cities saw a major increase in auto theft. The city continues to have a low auto theft rate compared to other cities in the county.

Firebaugh PAL


Firebaugh Police Activities League (PAL) suspended their 2020 activities due to COVID-19 restrictions and the safety of everyone involved. Firebaugh PAL is led by a board of directors who volunteer their time to oversee fundraising, expenses, youth sports programs. The PAL Program remains a popular organization among our residents. Over the years, Firebaugh PAL has organized a girls' softball league,



summer youth soccer league, youth tennis, toys for children and many other activities.



In October of 2020, PAL sponsored a Trick-or-Treat Drive-Thru for Firebaugh Children. PAL board members and patrol officers handed out over 600 candy bags. The drive thru helped control the amount of children Trick or Treating during COVID-19 restrictions.
