PENALTIES AND FINES – FIRST READING.

Open Hearing at 6:11 pm — Michael from Shogy's Market stated when the 1st amended ordinance came out, 5 to 6 retailers supported against kids smoking, but doesn't see how banning the sale of flavored tobacco will help, because they will able to go to others stores in other communities or other sources, like online services where no ID is required, to make their purchases. Rolando Castro, Mayor of Mendota supports this ordinance, which is why he participated in the meeting. City Attorney clarified a section of the ordinance," Section 8. Section 4-5.13 of the Firebaugh Municipal Code, as defined in section 4-5.3, subsection (e), except within an a tobacco store, as defined by section 4-5.3, subsection (j)." and (l) TOBACCO STORE — shall mean a retail business that meets all of the following requirements: primarily sells tobacco products, generates more than 60% of its gross revenues annually from the sale of tobacco products and tobacco paraphernalia, does not sell alcoholic beverages or food for consumption on the premises, and does not permit any person under 18 years of age to be present or enter the premises at any time." Meaning a store must receive 60% of their profits from tobacco products, such as smoke shops. — Hearing closed at 6:20 pm

- Mr. Mark Benjamin of Board of Supervisor Brain Pacheco's Office -
- Mario Gouveia, City Engineer Sewer project is wrapping up, with the final inspection tomorrow & working on 8th St is going well. Slurry Seal was awarded, the project should start within another month or less. Council Member Lopez asked about the Highway 33 project, noticed some expenditures from the grant. City Engineer replied, that funds were spent on electric specification that were submitted to Caltrans, so the City is waiting for their approval.
- Deputy City Clerk, Rita Lozano please provide me with any individuals that you would like on the guest list for the VFW Ribbon Cutting Event, we will have to move the event from the original proposed date. I have received a few, but not many.

- Fire Chief, John Borboa is out on a call.
- Police Chief, Sal Raygoza Officers & dispatchers are doing an awesome job at keeping the community safe, Crime rate is low. We did serve a search warrant on Friday, we developed info of an indoor cannabis grow, that we shut down. I'm glad we were able to put them out of business, it was a very sophisticated operation. We will continue to keep an eye out for those types of businesses to try to keep them out of our community. I've been attending a bunch of meetings with Chiefs & other departments, it seems there will be a lot of hiring in several Police Departments within the next year or so, & they're going to be offering between \$10,000 to \$15,000 signing bonus to their new hires with experience to go to their departments, so I anticipate that we may lose officers that want to get paid more or collect the bonus. Council Member Lopez asked, Sal for an update on the accident at Firebaugh Tire. Chief stated, "I don't really want to comment on it, it was an unfortunate accident. It was a 16 year old, who was working on a car, under the car, & the car fell, crushing him, & unfortunately he ended up passing away. I don't want to say much more, because incident is still under investigation, so I won't be saying much else."
- Eity Manager, Ben Gallegos— we will do the final walk through at VFW tomorrow, some pre-construction meetings for the Slurry this week also. One thing I wanted to bring to your attention, but is out of our control, & I going to have a conversation with the developer tomorrow. Is at the new homes at Greystone, you know, when you buy a house you pick your lot or house that you want, Well, they're not doing that over there, they're just building, & whatever's available, if you want the house you but it, type of deal. I did talk to the developer because of prices, are high, so whatever material he can get is what he is building, so I have received some complaints about it. I spoke with the developer, he explained why he's doing what he's doing, I don't think it's practicable, I told him he may be losing customers, since they don't get to pick what they want. The most expensive homes out there is over \$310,000, which is a surprise for our community. If you're going to pay that much you should be able to pick the house or lot that you want, in my opinion. We're still working to finish up on some of the details on the other development, when it comes to Diaz St., there's some comments from Caltrans, they're kind of pushing back a little bit, but we're still staying firm & saying they have to build it. That was part of the conditions that were approved that they were going to put those streets in, so were pushing to put it in. The planning commission approved the Conditional Use Permit (CUP) for the proposed dispensary, but with additional conditions. Annexation of Washoe has been submitted to LAFCo, hard copies & check for \$24,000.

ORDINANCE NO. 21-03

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH AMENDING ARTICLE 5 OF CHAPTER 4 OF THE FIREBAUGH MUNICIPAL CODE RELATING TO TOBACCO RETAILERS, AMENDING SECTION 3-12.2 RELATING TO TOBACCO PROHIBITIONS ON CITY PROPERTY; AND AMENDING SECTION 1-5.5.11 RELATING TO THE COLLECTION OF PENALTIES AND FINES.

WHEREAS, State and Federal law have increased the legal purchasing and consumption age of tobacco products to 21 years of age;

WHEREAS, over the last two years, the Firebaugh Police Department has experienced an increase in children illegally purchasing and consuming tobacco products;

WHEREAS, the health, safety and welfare of its citizens is of substantial interest to the City of Firebaugh; and

WHEREAS, the City of Firebaugh wishes to amend its Municipal Code to comply with current State and Federal law relating to tobacco age restrictions, and also to strengthen its ordinances relating to tobacco prohibitions, licensing, and enforcement.

The City Council of the City of Firebaugh does hereby ordain as follows:

Section 1. Section 4-5.1 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.1 Legislative Findings.

The City Council finds and determines that:

- a. State law prohibits the sale or furnishing of cigarettes, tobacco products, and smoking paraphernalia to minors, as well as the purchase, receipt, or possession of tobacco products by persons under 21 years of age (Penal Code 308).
- b. State law requires that tobacco retailers check the identification of tobacco purchasers who reasonably appear to be under 21 years of age (Business & Professions Code 22956) and provides procedures for using persons under 21 years of age to conduct onsite compliance checks of tobacco retailers (Business & Professions Code 22952).
- c. State law requires that tobacco retailers post a conspicuous notice at each point of sale, stating that selling tobacco products to anyone under 21 years of age is illegal (Business & Professions Code 22952, Penal Code 308).
- d. State law prohibits the sale or display of cigarettes through a self-service display and prohibits public access to cigarettes without the assistance of a Clerk (Business & Professions Code 22962).
- e. State law prohibits the sale of bidis (hand rolled filter less cigarettes imported primarily from India and Southeast Asian countries) except at those businesses that prohibit the presence of minors (Penal Code 308.1).

- f. State law prohibits the manufacture, distribution, or sale of cigarettes in packages of less than twenty (20) and prohibits the manufacture, distribution, or sale of "roll-your-own" tobacco in packages containing less than 0.6 of an ounce of tobacco (Penal Code 308.3).
- g. State law prohibits public school students from smoking or using tobacco products while on campus, while attending school-sponsored activities, or while under the supervision or control of school district employees (Education Code 48901(a)).
- h. 88% of adults who have ever smoked tried their first cigarette by the age of 18, and the average age at which smokers try their first cigarette is 14 1/2.
- i. The City of Firebaugh has a substantial interest in promoting compliance with Federal, State, and local laws intended to regulate tobacco sales and use; in discouraging the illegal purchase of tobacco products by minors; in promoting compliance with laws prohibiting sales of cigarettes and tobacco products to minors; in addressing the public health concerns related to tobacco use by minors; and in protecting children from being lured into illegal activity through the misconduct of adults.
- j. California courts in *Cohen v. Board of Supervisors*, 40 Cal. 3d 277 (1985), and *Bravo Vending v. City of Rancho Mirage*, 16 Cal. App. 4th 383 (1993), have affirmed the power of local jurisdictions to regulate business activity in order to discourage violations of law.
- k. State law authorizes local tobacco retailer licensing laws to provide for the suspension or revocation of the local tobacco retailer license for any violation of a State tobacco control law (Business & Professions Code 22971.3).
- A requirement for a tobacco retailer license will not unduly burden legitimate business
 activities of retailers who sell or distribute cigarettes or other tobacco products to
 persons 21 years of age or older. It will, however, allow the City to regulate the operation
 of lawful businesses to discourage violations of Federal, State, and local tobacco-related
 laws."

Section 2. Section 4-5.3 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.3 Definitions.

The following words and phrases, whenever used in this section, shall have the meanings defined in this subsection unless the context clearly requires otherwise:

- a. ARM'S LENGTH TRANSACTION shall mean a sale in good faith and for valuable consideration that reflects the fair market value in the open market between two informed and willing parties, neither of which is under any compulsion to participate in the transaction. A sale between relatives, related companies or partners, or a sale for which a significant purpose is avoiding the effect of the violations of this section is not an arm's length transaction.
- b. CITY MANAGER shall mean the City Manager of the City of Firebaugh or his or her designee.
- c. DEPARTMENT shall mean the Firebaugh Police Department.

- d. DRUG PARAPHERNALIA shall have the definition set forth in California Health and Safety Code Section 11014.5, as that section may be amended from time to time.
- e. PROPRIETOR shall mean a person with an ownership or managerial interest in a business. An ownership interest shall be deemed to exist when a person has a 10% or greater interest in the stock, assets, or income of a business other than the sole interest of security for debt. A managerial interest shall be deemed to exist when a person can or does have or shares ultimate control over the day-to-day operations of a business.
- f. SELF-SERVICE DISPLAY shall mean the open display of tobacco products or tobacco paraphernalia in a manner that is accessible to the general public without the assistance of the retailer or employee of the retailer. A vending machine is a form of self-service display.
- g. TOBACCO PARAPHERNALIA shall mean any item designed or marketed for the consumption, use, or preparation of tobacco products, including, but not limited to, cigarette papers or wrappers, pipes, holders of smoking materials of all types, cigarette rolling machines, and any other item designed for the smoking, preparation, storing, or consumption of tobacco products. [Amended 5-20-2019 by Ord. No. 19-02]
- h. TOBACCO PRODUCT shall mean: 1) any product containing, made or derived from tobacco or nicotine that is intended for human consumption, whether smoked, heated, chewed, absorbed, dissolved, inhaled, snorted, sniffed or ingested by any other means, including, but not limited to, cigarettes, cigars, little cigars, pipe tobacco, hookah tobacco, snuff, chewing tobacco, dipping tobacco, bidis, or any other preparation of tobacco; 2) any product or formulation of matter containing biologically active amounts of nicotine that is manufactured, sold, offered for sale, or otherwise distributed with the expectation that the product or matter will be introduced into the human body; and 3) any electronic device that delivers nicotine or other substances to the person inhaling from the device, including, but not limited to, an electronic cigarette, electronic cigar, electronic pipe, or electronic hookah. "Tobacco product" does not include any product specifically approved by the United States Food and Drug Administration for sale as a tobacco cessation product or for other therapeutic purposes where such product is marketed and sold solely for such an approved purpose. [Amended 5-20-2019 by Ord. No. 19-02]
- TOBACCO RETAILER shall mean any person who sells, offers for sale, or exchanges or offers to exchange, for any form of consideration, tobacco, tobacco products, or tobacco paraphernalia, or who distributes free or low cost samples of tobacco products or tobacco paraphernalia.
- j. TOBACCO RETAILING shall mean selling, offering for sale, exchanging, or offering to exchange for any form of consideration tobacco, tobacco products, or tobacco paraphernalia without regard to the quantity sold, offered for sale, exchanged, or offered for exchange.
- k. TOBACCO STORE shall mean a retail business that meets all of the following requirements: primarily sells tobacco products, generates more than 60% of its gross revenues annually from the sale of tobacco products and tobacco paraphernalia, does not sell alcoholic beverages or food for consumption on the premises, and does not permit any person under 18 years of age to be present or enter the premises at any time."

Section 3. Section 4-5.4 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.4 Tobacco Retailer License Required.

- a. It shall be unlawful for any person to act as a tobacco retailer (i.e., sell or offer to sell tobacco products) without first obtaining and maintaining a valid tobacco retailer's license pursuant to this section for each location at which that activity is to occur. Tobacco retailing without a valid tobacco retailer's license is a public nuisance.
- b. A tobacco retailer or proprietor without a valid tobacco retailer license, including without limitation a person whose license has been revoked:
 - 1. Shall keep all tobacco products and tobacco paraphernalia out of public view. The public display of tobacco products or tobacco paraphernalia in violation of this provision shall constitute tobacco retailing without a license and shall be subject to the penalties provided herein.
 - 2. Shall not display any advertisement relating to tobacco products or tobacco paraphernalia that promotes the sale or distribution of such products from the tobacco retailer's location or that could lead a reasonable consumer to believe that such products can be obtained at that location.
- c. Nothing in this section shall be construed to grant any person obtaining and maintaining a tobacco retailer's license any status or right other than the right to act as a tobacco retailer at the location in the City identified on the face of the license.
- d. Any violation of this section is considered a misdemeanor and is punishable by the provisions provided in section **4-5.20**, including but not limited to civil penalties of up to \$1,000 for each violation."

Section 4. Section 4-5.6 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.6 <u>Limits on Tobacco Retailer Licenses.</u>

- a. No license will be issued to authorize tobacco retailing at other than a fixed location.
- b. No license will be issued for itinerant tobacco retailing or tobacco retailing from vehicles.
- c. The number of tobacco retailer licenses issued within the City shall not exceed fourteen (14). City Staff shall assess the limit on tobacco retailer licenses every two years to evaluate whether to recommend to the City Council an amendment to this Article to change the number of permitted licenses as reasonably necessary to advance the public health and law enforcement purposes this Article seeks to achieve.
- d. No tobacco retailer license shall be issued for the sale of tobacco products within six hundred (600) feet of any school, public park, or playground, as measured by a straight line from the nearest point of the property line of the parcel on which the business is located, to the nearest point on which a school, public park, or playground is located."

Section 5. Section 4-5.8 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.8 Issuance and Renewal of License.

- a. Upon the receipt of an application for a license and the applicable license fee, the City manager shall issue a license unless:
 - 1. The application is incomplete or inaccurate;
 - 2. The application seeks authorization for tobacco retailing at an address that appears on a license that has been revoked, or is subject to revocation proceedings for violation of any of the provisions of this section; provided, however, this subparagraph shall not constitute a basis for denial of a license if either or both of the following apply:
 - (a) The applicant provides the City manager with documentation demonstrating that the applicant has acquired or is acquiring the premises or business in an arm's length transaction;
 - (b) It has been more than five (5) years since the most recent license for that location was revoked;
 - The application seeks authorization for tobacco retailing that is unlawful or unauthorized pursuant to this Code, including applicable zoning regulations, or that is unlawful or unauthorized pursuant to any other local, State, or Federal law; or
 - 4. The City has information that the applicant or his or her agents or employees have violated any local, State, or Federal tobacco control law at the location for which the license or renewal of the license is sought within the preceding thirty-day (30) period.
 - 5. The City has already issued the maximum number of tobacco retailer licenses, as referenced in section **4-5.6**, subsection (c) of this Article.
- b. A license shall be valid for one year and must be renewed not later than 30 days prior to the expiration of the license, but no earlier than 60 days prior to the expiration of the license. Unless revoked on an earlier date, all licenses shall expire one year after the date of issuance. A license may be renewed for additional periods of one year by submitting an application to the department and payment of the applicable license fee; provided, however, a license that has been revoked, or is subject to revocation proceedings, shall not be renewed. The application and license fee shall be submitted at least 30 days, but not more than 60 days, prior to the expiration of the current valid license. The applicant shall follow all of the procedures and provide all of the information required by section 4-5.7.
- c. Where the City manager does not approve a license or renewal of a license, the City manager shall notify the applicant of the specific grounds for the denial in writing. The notice of denial shall be served personally or by mail not later than five working days after the date of the denial. If by mail, the notice shall be placed in a sealed envelope, with postage paid, and shall be addressed to the applicant at the address as it appears on the application. The giving of notice shall be deemed complete at the time of deposit of the notice in the mail or at the time of personal service. Personal

service to a corporation may be made by delivery of the notice to any person designated in the Code of Civil Procedure to be served for the corporation with summons and complaint in a civil action."

Section 6. Section 4-5.10 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.10 <u>License Fee</u>.

The fee to issue or to renew a tobacco retailer's license shall be established by resolution of the City Council. The fee shall be calculated so as to recover the total cost of both license administration and license enforcement, including, for example, issuing the license, administering the license program, retailer education, retailer inspection and compliance checks, documentation of violations, and prosecution of violators, but shall not exceed the total cost of the program. All fees shall be used to fund the program. Fees are nonrefundable except as may be required by law."

Section 7. Section 4-5.11 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.11 <u>Expiration of License.</u>

- a. A tobacco retailer's license that is not timely renewed shall expire at the end of its term. To reinstate a license that has expired, or to renew a license not timely renewed, the proprietor must:
 - 1. Submit the full license fee amount that is due, plus a reinstatement fee equal to the full license fee amount; and
 - 2. Submit a signed affidavit affirming that the proprietor:
 - (a) Has not sold and will not sell any tobacco product or tobacco paraphernalia after the license expiration date and before the license is renewed and shall comply with the provisions provided within section 4-5.4; or
 - (b) Following the proprietor's last act of tobacco retailing, has waited the appropriate ineligibility period established for tobacco retailing without a license before seeking renewal of the license, as provided by section 4-5.5."

Section 8. Section 4-5.13 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.13 License Prohibitions.

- a. No person engaged in tobacco retailing shall sell or transfer a tobacco product or tobacco paraphernalia to another person who appears to be under the age of 21 without first examining the identification of the recipient to confirm that the recipient is at least the minimum age under State law to purchase and possess the tobacco product or tobacco paraphernalia.
- b. No person who is younger than the minimum age established by State law for the purchase or possession of tobacco products shall engage in tobacco retailing.

- c. No tobacco retailer shall display tobacco products or tobacco paraphernalia by means of a self-service display or engage in tobacco retailing by means of a self-service display.
- d. No tobacco retailer shall sell or transfer a tobacco product or tobacco paraphernalia to a person who is younger than the minimum age established by State Law.
 - 1. Any violation of this subsection shall result in the revocation of the tobacco retailer's license as further provided for in section **4-5.15**.
- e. It shall be a violation of a tobacco retailer's license for a licensee or his or her agent or employee to violate any provision of this section or any other local, State, or Federal tobacco-related law.

Section 9. Section 4-5.15 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.15 Revocation of License or Fine in Lieu Thereof.

- a. In addition to any other penalty provided by law, a tobacco retailer's license shall be revoked if the City manager finds, or any court of competent jurisdiction determines, after the licensee is afforded notice and an opportunity to be heard, that the licensee, or any of the licensee's agents or employees, have violated any of the requirements, conditions, or prohibitions of this section or in a different legal proceeding has pleaded guilty, "no contest" or its equivalent, or admitted to a violation of this section.
- b. The City manager may allow a tobacco retailer alleged to have violated this section to stipulate to the penalties provided in this subsection in lieu of the penalties that would otherwise apply under this section and to forego a hearing on the allegations. Stipulations shall not be confidential and shall contain the following terms plus any other noncriminal provisions established by the City manager in the interests of justice:
 - 1. After a first alleged violation of this section at a location:
 - (a) An agreement to stop acting as a tobacco retailer for one day;
 - (b) An administrative penalty of \$500; and
 - (c) An admission that the violation occurred and a stipulation that the violation will be considered in determining the penalty for any future violation.
 - 2. After a second alleged violation of this section at a location within any sixty-month period:
 - (a) An agreement to stop acting as a tobacco retailer for ten (10) days;
 - (b) An administrative penalty of at least \$1,000; and
 - (c) An admission that the violation occurred and a stipulation that the violation will be considered in determining the penalty for any future violations.
- c. Any tobacco retailer whose license has been revoked shall comply with all the provisions of section **4-5.4** of this Article."

Section 10. Section 4-5.20 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.20 Enforcement.

- a. The remedies provided by this section are cumulative and in addition to any other remedies available at law or in equity including the provisions of Municipal Code Chapter 4.
- b. Causing, permitting, aiding, abetting, or concealing a violation of any provision of this Article shall constitute a violation.
- c. Any person violating any section of this Article is subject to the payment of civil penalties of up to \$1,000 for each violation, unless otherwise specifically provided for therein. Any continuing violation shall constitute a separate offense for each day of the violation.
- d. Violation of any portion of this this Article shall be considered a misdemeanor, and is hereby declared to be a public nuisance.
- e. Violations of this Article are hereby declared to be unfair business practices and are presumed to at least nominally damage each and every resident of the community in which the business operates.
- f. In addition to other remedies provided by this section or by other law, any violation of this Article may be remedied by a civil action brought by the City including administrative or judicial nuisance abatement proceedings, civil or criminal code enforcement proceedings, and suits for injunctive relief.
- g. Whenever evidence of a violation of this Article is obtained in any part through the participation of a person under the age of 18 years old, such a person shall not be required to appear or give testimony in any civil or administrative process brought to enforce this section and the alleged violation shall be adjudicated based upon the sufficiency and persuasiveness of the evidence presented."

Section 11. Section 4-5.20 of the Firebaugh Municipal Code is hereby amended to read as follows:

"4-5.21 Severability.

If any subsection, subdivision, paragraph, sentence, clause or phrase hereinafter part of this Article or its application to any person or circumstance is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining subsections, subdivisions, paragraphs, sentences, clauses, or phrases parts of this Article or its application to any other person or circumstance. The City Council hereby declares that it would have adopted each part hereof irrespective of the fact that anyone or more other parts hereof be declared invalid or unenforceable.

Section 12. Section 3-12.2 of the Firebaugh Municipal Code is hereby amended to read as follows:

"3-12.2 Tobacco Product Use Prohibited on City Property.

a. No person shall smoke or use a tobacco product on City property, including but not limited to: City parks, playgrounds, plazas, recreational areas and facilities, public

restrooms, parking garages, within twenty-five (25) feet of any bus stop, or on any public street or sidewalk within school twenty-five (25) feet of any K-12 school property.

- b. Smoking is otherwise permitted on City-owned streets open to normal traffic and on adjacent sidewalks. When City-owned streets and adjacent sidewalks are used for events including, but not limited to, a farmers' market or parade, smoking and tobacco product use is prohibited on such streets and sidewalks during the event, including set-up and tear-down.
- c. "No smoking" signs, with letters of no less than one inch in height or the international "No smoking" symbol (consisting of a pictorial representation of a burning cigarette enclosed in a red circle with a red bar across it) shall be clearly, sufficiently and conspicuously posted by the City Manager or his or her designee on City property where smoking and tobacco products are prohibited by this chapter. Signage must include the City phone number where complaints can be directed. Notwithstanding this provision, the presence or absence of signs shall not be a defense to the violation of any provision of this Article 3-12.
- d. No person shall dispose of smoking waste or tobacco-product waste on City property on which smoking or tobacco product use is prohibited, except in a designated waste disposal container.
- e. Consistent with Health and Safety Code Section 11362.3, Subdivisions (a)(1) and (2), no person shall smoke or ingest cannabis in any public place within the City nor shall they smoke cannabis anywhere smoking tobacco is prohibited.

Section 13. Section 1-5.5.11 of the Firebaugh Municipal Code is hereby amended to read as follows:

"1-5.5.11 <u>Collection of Penalty</u>.

The City may file a legal action, impose a lien as set forth below, or pursue any other legal remedy to collect a penalty that has become final as provided in this section. The City may impose a lien in the amount of the confirmed penalty against the property that is the subject of an administrative citation and penalty, if the citation has been issued to the property owner. The City may record a notice of lien in the office of the county recorder. After the notice of lien is recorded, a copy may be turned over to the county tax collector to add the amount of the unpaid penalty to the next regular tax bill levied against the property for property taxes. Those amounts shall be collected at the same time and in the same manner as ordinary property taxes are collected, and shall be subject to the same penalties and procedures under foreclosure and sale in case of delinquency as provided for ordinary property taxes. Alternatively, after recording, the lien may be foreclosed by judicial or other sale in the manner and means provided by law. The notice of lien shall be in a form approved by the City Manager and the City Attorney. In any action, administrative proceeding, or special proceeding to abate a nuisance, the prevailing party of said action may recover its reasonable attorneys' fees.

Section 14. License fees for tobacco retailer licenses may be established and modified from time to time by resolution of the City Council.

Section 15. This ordinance shall take effect thirty (30) days after its adoption.

Section 16. The City Clerk is authorized and directed to cause this ordinance to be codified after its adoption.

Section 17. The City Clerk is further authorized and directed to cause this ordinance or a summary of this ordinance to be published once in a newspaper of general circulation published and circulated in the City of Firebaugh within fifteen (15) days after its adoption. If a summary of this ordinance is published, then the City Clerk also shall cause a summary of the proposed ordinance to be published and a certified copy of the full text of the proposed ordinance to be posted in the office of the City Clerk at least five (5) days prior to the Council's meeting at which the ordinance is adopted and again after the meeting at which the ordinance is adopted. The summary shall be approved by the City Attorney.

SUBJECT:

Adopt a resolution approving the City of Firebaugh FY 21/22 list of eligible projects for funding from the Road Maintenance and Rehabilitation Account (RMRA) created by Senate Bill (SB) 1 Road Repair and Accountability Act of 2017, and authorizing the City Manager to file with the California Transportation Commission (CTC) the Project List and the Annual Expenditure Report for FY 21/22 RMRA Funding.

BACKGROUND

Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor on April 28, 2017, in order to address the transportation funding shortfalls statewide. The 2016 California Statewide Local Streets and Roads Needs Assessment found that a majority of the city streets and roads in California are at an "at-risk" condition and this funding will provide for improving the roads system. It is anticipated that over the next decade, SB 1 will contribute to restoring streets and roads into a "good" condition. SB 1 funding will be generated from increased gasoline and diesel fuel excise taxes and additional vehicle registration fees for California residents.

SB 1 includes accountability and transparency provisions to ensure the funding is used on a fiscal year basis for eligible transportation projects including, but not limited to, road maintenance and rehabilitation, safety projects, railroad grade separations, complete streets components, and traffic control devices. Funding recipients must prepare a list of eligible projects to receive funding from the Road Maintenance and Rehabilitation Account on a fiscal year basis with these funds appropriated in the City budget. This list must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement. Funding recipients will also be required to prepare annual reports to indicate expenditure levels and completion status for each proposed project on a fiscal year basis.

Cities and counties will receive an annual allocation, determined from a population formula, which will be distributed on a monthly basis. SB 1 mandates that this new RMRA funding must not be used to supplant the current level of General Fund expenditures for street improvements and will be subject to oversight by the State Controller as part of the accountability and transparency provisions.

DISCUSSION

This year's allocation corresponds to the fifth year of funding and the fourth consecutive full allocation since the program's inception. The funds were first made available to cities and counties during Fiscal Year 2017-2018 as a partial allocation from the regular fiscal year amount.

In order to receive the FY 21/22 SB 1 funding, the City of Firebaugh must submit to the California Transportation Commission by June 1, 2021, or as extended by the Commission, a list of eligible projects approved by resolution by the City Council and submitted electronically using the CTC-developed an online tool.

The City has determined a project list consisting of any new projects to be funded with the RMRA FY 21/22 allocation and previously proposed and adopted projects (re-listed) for the RMRA Program.

The City of Firebaugh's FY 21/22 allocation is estimated at \$158,937 per the Local Streets and Roads – Projected Revenues dated January, 2021 and as published by the California City Finance website. It is recommended that these funds be appropriated for the following new or re-listed eligible projects:

- 1. 13th Street Rehabilitation (from O Street to Bridge over the San Joaquin River) New
- 2. 12th Street Rehabilitation (from Washoe Avenue to M Street) New

The attached project list (Exhibit 1) provides more detail including the project description, location, estimated completion date, and useful life.

The City's FY 21/22 Budget will include the following revenue and expenditure items for the FY 21/22 SB 1 Allocation:

Revenue: Road Maintenance and Rehabilitation Account: \$158,937 Expenditure: Road Maintenance and Rehabilitation Projects: \$158,937

FISCAL IMPACT

The expenditures for the FY 21/22 eligible projects are anticipated to be funded 100% from the City's Road Maintenance and Rehabilitation Account. The proposed project expenditures for FY 21/22 are anticipated to match the estimated revenue of \$158,937 for FY 21/22.

RECOMMENDATION

Staff recommends that the City Council adopt Resolution No. 21-23, as follows:

- 1. Approving the City of Firebaugh FY 21/22 List of eligible projects for funding from the Road Maintenance and Rehabilitation Account administered by the California Transportation Commission in partnership with the State Controller's office, and
- 2. Authorizing the City Manager to file with the California Transportation Commission the Project List and Annual Expenditure Report for FY 21/22 RMRA Funding.

WHEREAS, RMRA funding will be generated from increased gasoline and diesel fuel excise taxes and additional vehicle registration fees for California residents, cities and counties will receive an annual allocation, determined from a population formula, which will be distributed on a monthly basis; and

WHEREAS, SB 1 includes accountability and transparency provisions to ensure the funding is used on a fiscal year basis for eligible transportation projects including, but not limited to, road maintenance and rehabilitation, safety projects, railroad grade separations, complete streets components, and traffic control devices, this new RMRA funding must not be used to supplant the current level of General Fund expenditures for street improvements and will be subject to oversight by the State Controller's office; and

WHEREAS, funding recipients must prepare a list of eligible projects to receive funding from the Road Maintenance and Rehabilitation Account on a fiscal year basis and approved by resolution by the governing board. This list must include a description and location of each proposed project, a proposed schedule for completion, and the estimated useful life of the improvements; and

WHEREAS, the City has ensured public input and developed the most high-priority and costeffective projects to receive SB 1 revenues and that would meet the City's priorities for transportation investment; and

WHEREAS, the selected project list includes any new projects to be funded with the RMRA FY 21/22 allocation and previously proposed and adopted projects (re-listed) to reaffirm the public and the State the City's intent to fund these projects with Road Maintenance and Rehabilitation Account revenues; and

WHEREAS, the City of Firebaugh's FY 2021/2022 allocation for RMRA funding is estimated at \$158,937 and the City intends to appropriate these funds on its FY 21/22 Budget.

WHEREAS, the City's FY 2021/2022 allocation will be designated to the new or re-listed eligible projects listed below and as shown on Exhibit 1:

- 1. 13th Street Rehabilitation (from O Street to Bridge over the San Joaquin River) New
- 2. 12th Street Rehabilitation (from Washoe Avenue to M Street) New; and

WHEREAS, the City is required to submit to the California Transportation Commission by July 1, 2021, or as extended by the Commission, the FY 2021/2022 List of eligible projects and a resolution that shows these projects were approved to receive FY 21/22 SB 1 funds; and

WHEREAS, funding recipients must prepare an annual report to indicate expenditure levels and completion status for each proposed project on a fiscal year basis.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Firebaugh hereby:

- 1. The above recitals are true and correct findings of the Firebaugh City Council.
- 2. The City Council hereby approves the above proposed FY 2021/2022 List for eligible projects to receive funding from the Road Maintenance and Rehabilitation Account.
- 3. The FY 21/22 SB 1 funds will be appropriated on the City's FY 21/22 Budget.
- 4. The City Manager is hereby authorized and directed to submit to the California Transportation Commission the Project List and Annual Expenditure Report for FY 2021/2022 RMRA Funding.

LEASE

This lease is made and entered into this ____ day of July, 2021 by and between the City of Firebaugh. hereinafter referred to as "LANDLORD" and Veterans of Foreign Wars, Post 7380, hereinafter referred to as "TENANT".

PREMISES:

Landlord hereby leases to Tenant and Tenant hereby leases from Landlord, on the terms and conditions hereinafter set forth, that certain real property and the building and other improvements located thereon situated in the City of Firebaugh, State of California at_____ Street, Firebaugh. Said real property is hereinafter called the Premises.

1. TERM:

The term of this Lease shall be for three (3) years commencing on July____ 2021 and ending on July____, 2024. Tenant shall have two one (1) year options which will be exercised unless either party provides a notice of termination sixty days prior to the expiration of the existing term.

2. RENT:

Tenant shall pay to Landlord as rent for the Premises, the sum of Eight Hundred Dollars (\$800.00) per month, in advance on the first day of each month during the term hereof. Rent shall be payable without notice or demand and without any deduction, off-set, or abatement in lawful money of the United States to the Landlord at the address stated herein for notices or to such other persons or such other places as the Landlord may designate to Tenant in writing.

3. TAXES:

(a) Real Property Taxes:

Tenant shall pay all property or possessory interest, taxes and general assessments levied and assessed against the Premises during the term of this Lease

(b) Personal Property Taxes:

Tenant shall pay prior to the delinquency all taxes assessed against and levied upon the trade fixtures, furnishings, equipment and other personal property of Tenant contained in the Premises.

4. UTILITIES:

Tenant shall make all arrangements and pay for all water, gas, heat, light, power, internet, phone, communication and other utility services supplied to the Premises together with any taxes thereon and for all connection charges.

5. ALTERATIONS AND ADDITIONS:

Tenant shall not, without the Landlord's prior written consent, make any alterations, improvements, or additions in or about the Premises.

6 HOLD HARMLESS/INSURANCE:

Tenant shall indemnify and hold Landlord harmless from and against any and all claims arising from Tenant's use or occupancy of the Premises or from the conduct of its business or from any activity, work or things which may be permitted or suffered by Tenant in or about the Premises including all damages, costs, attorney's fees, expenses and liabilities incurred in the defense of any claim or action or proceeding arising therefrom. Except for Landlord's willful or grossly negligent conduct, Tenant hereby assumes all risk of damage to property or injury to person in or about the Premises. Tenant shall provide evidence of insurance acceptable to Landlord which names Landlord as an additional insured.

7. ASSIGNMENT AND SUBLETTING:

Tenant shall not voluntarily or by operation of law assign, transfer, sublet, mortgage, or otherwise transfer or encumber all or any part of Tenant's interest in this Lease or in the Premises without Landlord's prior written consent which consent shall not be unreasonably withheld.

8. **DEFAULT**:

It is agreed between the parties hereto that if any rent shall be due hereunder and unpaid, or if Tenant shall default and breach any other covenant or provision of the Lease, then the Landlord, after giving the proper notice required by law, may re-enter the Premises and remove any property and any and all persons therefrom in the manner allowed by law. The landlord may, at his option, either maintain this Lease in full force and effect and recover the rent and other charges as they become due or, in the alternative, terminate this lease. In addition, the Landlord may recover all rentals and any other damages and pursue any other rights and remedies which the landlord may have against the Tenant and by reason of such default as pr6ovided by law.

9. SURRENDER:

On the last day of the term of this Lease, Tenant shall surrender the Premises to Landlord in good condition, broom clean, ordinary wear and tear and damage by fire and the elements excepted.

10. HOLDING OVER/TERMINATING LEASE:

If Tenant, with the Landlord's consent, remains in possession of the Premises after expiration or termination of the term of this Lease, such possession by Tenant shall be deemed to be a tenancy from month-to-month at a monthly rental in the amount of the last annual rental plus all other charges payable hereunder, and upon all the provisions of this Lease applicable to such a month-to-month tenancy. Either party may terminate this lease at any time by giving three months written notice of termination.

11. BINDING ON SUCCESSORS AND ASSIGNS:
