Several residents stated their concern with the mandated vaccine for employees and had questions for the Council and Doctors regarding the vaccine. Some of the resident that spoke were Linda D., Linda E. and Amanda S. Principal Catalan made recommendation to accommodate the employees that wish to not be vaccinated. Dr. John Zweifler, Dr. Rais Vohra & Dr. Sukhijit Dhillon responded to the questions, & explained how important it is, to not only receive the vaccine, but how safe it is. They also stated, they understand that there have been some cases of complications or allegoric reactions to the vaccine, but the number of those cases are very small compared to the number of individuals that have received the shot & the amount of lives the vaccines have saved, which is much higher.

Some of the resident that spoke, were Linda D., Linda E. and Amanda S, they stated their believe, that all employees should receive the same amount, whether they're vaccinated or not, & added it could be considered a form of discrimination, bribery or even inhumane to make individuals take a vaccine that they aren't comfortable with. They also asked, if Council going to consider the same requirement of themselves, or eventually, ask the public to follow the requirement to attend certain events, and/or the kids attending our local schools? Other comments were made by Silvia R, and Matt Garcia asked why Oct 4, 2021, was the deadline on the resolution & if a different date is possible.

- Bethany Matos, Associate Dean of North District Center Fall & Spring Semesters will be soft openings, there are several classes to begin, if anyone would like to enroll, West Hills will hold a resources fair event.
- Mr. Mark Benjamin of Board of Supervisor Brain Pacheco's Office 58% of Firebaugh's residents are vaccinated, Mendota rate increased and is a little higher, the youth cases in Firebaugh have gone up in Firebaugh, with about 85 cases, but the average current rate is 111 per 100,000 cases, which is good. 50% of countywide residents has received at least one COVID shot, other stats were also provided.

PD is trying to put together a City wide cleanup in late October. Crime rate is down, the city had a few crimes, but we believe we have identified him, as a criminal from Merced, but we are working on catching him.

I would like to thank Wonderful for their donation of \$3,000, which helped buy equipment to do a cleanup, due to COVID, we couldn't paint a home this year, but I think the Wonderful employees that volunteer really enjoy that project. I will be attending the League of Cities Conference Wednesday through Friday, we are receiving a lot of interest from new businesses that would like to come to Firebaugh, more than in the past, so I recommend us attending ICSC in December.

RESOLUTION NO. 21-38

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH MANDATING EMPLOYEE AND VOLUNTEER VACCINATIONS TO ENSURE THE SAFETY OF THE PUBLIC AND THE WORKPLACE AGAINST THE EXISTENCE OR THREATENED EXISTENCE OF A COVID-19 LOCAL EMERGENCY

WHEREAS, California Government Code section 8630 and Firebaugh Municipal Code section 2-11.6 empowers the City Council to proclaim a local emergency when the City is affected or likely to be affected by the actual or threatened existence of conditions of disaster or of extreme peril to the safety of persons within the City; and

WHEREAS, as empowered by Firebaugh Municipal Code section 2-11.6, the City's Director of Emergency Services has requested that the City Council proclaim the existence or threatened existence of a local emergency as a result of the COVID-19 pandemic and the resulting public health emergency; and

WHEREAS, the City Council has reviewed and considered the request from the Director of Emergency Services, dated March 18, 2020, and the findings stated therein, which request is incorporated herein by reference as though set forth in full; and

WHEREAS, based on conditions of disaster or of extreme peril to the safety of persons within the City caused by the threatened spread of COVID-19, the City Council on March 19, 2020 adopted Resolution No. 2020-017 declaring the existence of a local emergency; and

WHEREAS, the conditions of emergency have continued and increased due to the existence of the Delta variant and warrant and necessitate actions to secure the safety of the workplace for city employees and volunteers and the public that they serve.

NOW, THEREFORE, the City Council of the City of Firebaugh resolves as follows:

- 1. All City employees and volunteers shall demonstrate legal proof of COVID-19 vaccination by November 1, 2021.
- 2. Employees with religious and medical exemptions will be granted reasonable accommodation.
- 3. The City Manager is directed to implement this policy after meeting and conferring with City bargaining units on the effects of the policy on the terms and conditions of City employment.
- 4. This resolution shall take effect immediately upon adoption and fulfillment of the necessary requirements to meet and confer.

RESOULTION NO. 21-40

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH AUTHORIZING USE OF EMREGENCY REMOTE TELECONFERENCING PROVISIONS

WHEREAS, the City Council of the City of Firebaugh ("City Council") is committed to open and transparent government, and full compliance with the Ralph M. Brown Act ("Brown Act"); and

WHEREAS, the Brown Act generally requires that a public agency take certain actions in order to use teleconferencing to attend a public meeting virtually; and

WHEREAS, the City Council recognizes that a local emergency persists due to the worldwide COVID-19 pandemic; and

WHEREAS, the California Legislature has recognized the ongoing state of emergency due to the COVID-19 pandemic and has responded by creating an additional means for public meetings to be held via teleconference (inclusive of internet-based virtual meetings); and

WHEREAS, on September 16, 2021, the California legislature passed Assembly Bill ("AB") 361, which amends Government Code, section 54953 and permits a local agency to use teleconferencing to conduct its meetings in any of the following circumstances: (A) the legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; (B) the legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or (C) the legislative body holds a meeting during a proclaimed, by majority vote, pursuant to subparagraph (B), that, as a result of the emergency, meeting in person would present information of attendees; and

WHEREAS, in order for the City Council to use teleconferencing as allowed by AB 361 after October 1, 2021, it must first adopt findings in a resolution, allowing the City Council to conduct teleconferenced meetings for a period of thirty (30) days; and

WHEREAS, Governor Gavin Newsom declared a state of emergency for the State of California due to the COVID-19 pandemic in his order entitled "Proclamation of a State of Emergency," signed March 4, 2020; and

WHEREAS, the California Occupational and Safety Health Administration (OSHA) continues to recommend certain social distancing requirements, as described in detail in California Code of Regulations Title 8, section 3205 Covid Prevention; and

WHEREAS, the City Council hereby finds that the state and local emergencies have caused and will continue to cause imminent risks to the health or safety of attendees; and

WHEREAS, the City Council is conducting its meetings through the use of telephonic and internet-based services so that members of the public may observe and participate in meetings and offer public comment.

NOW, THEREFORE, **BE IT RESOLVED**, by the City Council of the City of Firebaugh as follows:

1. The City Council is conducting meetings during a state of emergency and OSHA recommends measures to promote social distancing.

2. The City Council has determined that given the state of emergency, holding in-person only meetings would present imminent risks to the health or safety of attendees.

3. The actions taken by the City Council through this resolution may be applied to all City boards and committees governed by the Brown Act unless otherwise desired by that body.

4. The City Council authorizes the City Manager or their designee(s) to take all actions necessary to conduct City Council meetings in accordance with Government Code section 54953(e) and all other applicable provisions of the Brown Act, using teleconferencing for a period of thirty (30) days from the adoption of this Resolution after which the City Council will reconsider the circumstances of the state of emergency.

5. Staff is directed to return no later than thirty (30) days after the adoption of this resolution with an item for the Board to consider making the findings required by AB 361 in order to continue meeting under its provisions.

The foregoing resolution is effective upon adoption and was approved and adopted at a regular meeting of the City Council of the City of Firebaugh held on the 4th day of October, 2021, by the following vote:

the Firebaugh Fire As part of its Centennial, Department have the owners of Whitehurst are honoring various groups in the Westside communities that they serve--Los Banos, Dos Palos, and Firebaugh-with a "Community Strong" award.



Last week, Tony Whitehurst visited the Firebaugh Volunteer Fire Department during their regular training meeting to honor the firefighters and first responders with the award.

Before both members and student cadets, Whitehurst noted that the FFD marked its beginning in 1920.

"This recognition is proudly given to the Firebaugh Volunteer Fire Department to mark a 100 year legacy of constant vigilance and dedication to the protection of the community," Whitehurst said.

Whitehurst noted that Chief John Borboa is the third member of his family to oversee the department, following his father Casey and grandfather Ramon Sr., who was the city's first fire chief.

"This continuous succession of chiefs spans three generations," said Whitehurst. "The volunteer fire department that they have guided directly reflects the very same dedication and pride."

He added that the Whitehurst family "is truly grateful for the opportunity to serve alongside the many individuals and organizations who continually step up together to help keep our community safe and strong."

The presentation of the "Community Strong" award was made in the old, cramped quarters of the department's meeting room.

But that will be changing.

Currently under construction on "Q" Street in Firebaugh is the department's new fire station. The 7,000 square foot building is being erected at a cost of \$5 million and should be finished in March of 2022.
