Re: *Notice of Intent of the City of Firebaugh to Adopt Amended Groundwater Sustainability Plan*

The City of Firebaugh Groundwater Sustainability Agency hereby provides notice of its intent to adopt an amended Groundwater Sustainability Plan no earlier than 90 days from the date of this Notice. Adoption of the amended Groundwater Sustainability Plan shall occur as part of a public hearing to be held by the City of Firebaugh Groundwater Sustainability Agency. Once adopted, the amended Groundwater Sustainability Plan will govern sustainable groundwater management actions within the jurisdictional boundaries of this plan located in the Delta-Mendota Subbasin (Groundwater Basin: 5-022.07) as encompassed by the boundaries of the City of Firebaugh (GSA) Groundwater Sustainability Agency & the San Joaquin River Exchange Contractors Groundwater Sustainability Agency (SJRECGSA). This notice is specifically given to the City of Firebaugh and County of Fresno, which are the cities and counties within the area of the proposed amended the City of Firebaugh (GSA) Groundwater Sustainability Agency.

The amended City of Firebaugh Groundwater Sustainability Agency & the San Joaquin River Exchange Contractors Groundwater Sustainability Agency (SJRECGSA) Groundwater Sustainability Plan (GSP) that is the subject of this Notice will address and remediate the issues identified in the California Department of Water Resources January 21, 2022, correspondence identifying corrective actions that must be completed within 180 days of the determination.<sup>1</sup>

Cities or counties that receive this notice may request in writing to consult with City of Firebaugh (GSA) Groundwater Sustainability Agency concerning the amended the San Joaquin River Exchange Contractors Groundwater Sustainability Agency (SJRECGSA) Groundwater Sustainability Plan (GSP). These requests must be received by the City of Firebaugh (GSA) Groundwater Sustainability Agency at the contact information provided below within 30 calendar days upon receipt of this notice.
