4. THE CITY COUNCIL OF THE CITY OF FIREBAUGH TO CONSIDER AND DISCUSS A DEDICATION PLAQUE TO BE PLACED AT THE FIREBAUGH FIRE DEPARTMENT TO HONOR THE BORBOA FAMILY.

Council Member Renteria requested to have a plaque placed at the new fire station to honor the Borboa Family for the different generations of volunteer Firefighters & years of service over the past several decades to the City of Firebaugh Fire Department. Council Member Lopez agreed and supported the recommendation. One resident opposed honoring one person, John Borboa, stating he should not be the only recognized firefighter, and recommended all volunteer firefighters be honored for their volunteer service by placing their names on a plaque, too. Another resident supported honoring the Borboa Family, adding it's not about just one family member, but the Borboa Family, because of the different generations of Borboa family members that have served as volunteer firefighters, as far back as the early 1920s, and the years of service to the fire department as volunteer firefighters, but agreed, all volunteers should be recognized. Council Member Valdez mentioned a photo taken in 1922 of the original five firefighters & suggested this photo with the names of the Firefighters be placed at the fire station to honor them. Council Member Renteria, stated, "No other person or family has served on the Firebaugh Fire Department longer than the Borboa Family Members, which is why, she requested this item be placed on the agenda for consideration," Then, asked City Manager Gallegos, "If anyone else submit or requested anything else for consideration?" City Manager Gallegos replied, "No."

Motion to table item by Council Member Valdez, second by Council Member Jenkins, motion passed by 4-1 vote. Lopez – no.

Thanked public works staff for the overtime they have been doing, including working on the weekends to help with the flooding concerns, & want them to know their hard work has not gone unnoticed.
- Elected Officials Senators, House Representatives have all called to offer help if we need it, so I just want to thank everyone. A new project has been proposed, so council need to consider if they want to complete the Maldonado Park expansion or allow an apartment complex to be built on the undeveloped area. Thanked Pio, we have been in meetings all day on the flood issues, we do not take our decisions lightly, the water flows are going to continue to rise so we will continue monitoring them. Michael & I attended the Public Works Conference but did not get to stay because of the floods. At the conference we learned about funding for streets, and the pros and cons of subcommittees. City Manager will not be attending the next council meeting April 3, 2023, will be out on vacation.

- Finance Director, Pio Martin glad the audit is over, will be working on the budget for the next fiscal year, please submit items if you wish to include in the budget, staff is pushing for residents to use the "TextMyGov" app, so city has a better way to communicate with everyone, about various matters, including information on the flood.

- > Council Member Renteria Thanked everyone and staff that is out there working on the flood, at all hours of the day.
- > <u>Council Member Valdez</u> echoed the same as Council Member Renteria, on the great leadership, hard work and dedication staff has showed.
- > <u>Council Member Lopez</u> was involved in the 97 floods, I know how stressful it can be, thanked staff for the dedication, a lot of people start to worry, but if staff exercises good communication, & has an open-door policy, the community will find comfort in that, we don't want them to panic.

- > <u>Council Member Perez</u> staff is doing important work, and council is here to support the staff and community, so thank you very much. Asked about the streetsweeper update and reported issues of sitting water at Fr. Craig and the next two streets.

A Resolution of City of Firebaugh

Name of Institution or Organization

WHEREAS, the California Energy Commission provides loans to schools, hospitals, local governments, special districts, and public care institutions to finance energy efficiency improvements; and

NOW THEREFORE, BE IT RESOLVED, that City Council of the City of Firebaugh authorizes <u>SitelogIQ</u> to apply for an energy efficiency loan from the California Energy Commission to implement energy efficiency measures.

BE IT ALSO RESOLVED, that in compliance with the California Environmental Quality Act (CEQA), City of Firebaugh finds that the activity funded by the loan is a project that is categorically exempt under 15301, 15304,15311 and 15329 because the solar site proposed is part of an existing facility and/ or minor alterations to land.

BE IT ALSO RESOLVED, that if recommended for funding by the California Energy Commission, the City Council of the City of Firebaugh authorizes the City Manager to accept a loan up to \$500,000.00.

BE IT ALSO RESOLVED that the amount of the loan will be paid in full, plus interest, under the terms and conditions of the Loan Agreement, Promissory Note and Tax Certificate of the California Energy Commission.

BE IT FURTHER RESOLVED that City Manager, Ben Gallegos is hereby authorized and empowered to execute in the name of City of Firebaugh all necessary documents to implement and carry out the purpose of this resolution, and to undertake all actions necessary to undertake and complete the energy efficiency projects.

RECOMMENDATION:

1. Council by motion adopt Resolution No. 23-12 Initiating Proceedings for the Annual Levy of Assessments for the Landscaping and Lighting Maintenance District No. 1

2. Directs the City Engineer to prepare and file his annual report on the levy.

BACKGROUND:

The Assessment District was formed for the purpose of financing maintenance and improvement costs for street lighting, streets, public landscaping and park improvements in the District. The levy of assessments to property owners in the District occurs on an annual basis.

In order to meet the timelines required by the Landscaping and Lighting Act of 1972 (herein the "Act") and the Government Code, it is now necessary to initiate proceedings for the annual levy of assessments against all properties in the District. The City Engineer will need to prepare and file a report regarding the annual levy in accordance with Article 4 (commencing with Section 22565) of Chapter 1 of the Act.

No annexations of property have occurred to the District over the past year therefore there will be no new properties to levy.
