


25 MW Cenergy Installation for Indianapolis Airport



- 2. The program is set to open by July 1, 2024 by the CPUC.
- 3. Projects that have approvals from <u>municipalities</u> and <u>utility interconnection</u> will have the best chance at selection.






## Proposed Site Location is at the landfill





- Public Works Director, Michael Molina Working to cleanup the Rodeo Grounds, working on day-to-day operation. Responded to a fire at the Housing Authority on the early morning of July 24<sup>th</sup>, the Captain at 96, said it was a great stop. Received a Thank you letter from Red Rooster, regarding a fire at their location on July 24<sup>th</sup>, the fire is still under investigation, without the assistance from Madera and Fresno Counties, the city would have probably lost the company. Since everyone responded quickly and worked together to put the fire out, Red Rooster was able to start their operation later that day, after some cleanup. The Fire Department has relocated and moved to the new Fire Station. The department would like to purchase supplies to do Community and kid outreach. Hector Marin will be attending an event at the school to recruit more fire fighter volunteers, and he is managing the day-to-day operations at the office.

- Bethany Matos, Director of Admission and Records or Student Services of West Hill College-Firebaugh Center Reported the students are in the new building for this school year, including the Fresno County Library. Compared to 2019, before Covid, the college presently has 350 to 400 students enrolled to attend classes on campus, which up 20% compared to 2019in on ground class attendance. Several additional classes have been added to our local campus, summer school is always a challenge, most the summer classes are taken online. Dual Enrollment (high school students attending college classes) has about 270 students, which is up 64% from last year. This year, college classes were offered to eighth graders, they are called Jr. Falcons, all the students that participated past their courses, thirty-three students signed up in the spring. All the Mills students visited the college campus. Thanked everyone for supporting and passing Measure K, the college has changed their name form North District Center to Firebaugh Center. Short Term CPR and First Aid class will be offered in October 2023. Council Member Valdez, wanted to mention West Hills College offers great Adult Transition Classes, and thanked them.
- Fire Battalion, Hector Marin asked if West Hills College is going to bring back EMT Classes. Mrs. Matos explained any new curriculum takes at least a year to be able to offer a new class, but the college is looking at offering additional certification programs.
- Council Member Renteria wanted to mention, the college also offers work experience classes to High School Students which is an incredibly good experience and a great resource to the students. Thanked the staff for their hard work with the ribbon cutting ceremony.

#### ORDINANCE NO. 23-01

#### AN ORDINANCE OF THE CITY OF FIREBAUGH, COUNTY OF FRESNO, STATE OF CALIFORNIA, AMENDING ORDINANCE NO. 359, OF THE CITY OF FIREBAUGH, RELATING TO THE CLASSIFICATION OF THE ZONE OF PARTICULAR PARCELS OF REAL PROPERTY

The City Council of the City of Firebaugh does ordain as follows:

**SECTION 1.** Section 25-2.1 of the Municipal Code of the City of Firebaugh is amended by changing the Zoning Map to redesignate two existing parcels from "C-1" (Neighborhood Commercial) to "R-2" (Low Density Multiple Family Residential) as shown on Map 1. The subject parcels are situated on the east side of the Lyon Avenue alignment, approximately 540 feet north of N. Dos Palos Road.

**SECTION 2.** Severability. If any part of this Ordinance is held to be invalid for any reason, such decision shall not affect the validity of the remaining portions of this Ordinance, and the City Council hereby declares that it would have passed the remainder of this Ordinance, as if such invalid portion thereof had been deleted.

**SECTION 3.** This ordinance shall take effect thirty (30) days after its passage.

**SECTION 4.** The City Clerk is hereby ordered and directed to certify the passage of this Ordinance and to cause the same to be published once in a newspaper of general circulation, published in the County of Fresno.



#### **RESOLUTION NO. 23-42**

## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FIREBAUGH TO APPROVING AND RENEWING THE PROCLAMATION OF A LOCAL EMERGENCY ISSUED ON MARCH 11, 2023, BY THE FIREBAUGH DIRECTOR OF EMERGENCY SERVICES AND DECLARING A CONTINUING LOCAL EMERGENCY

WHEREAS, the City Council ratified and confirmed the Proclamation of the existence of a local emergency within the City on the 16th day of March, 2023; and

**WHEREAS**, the City Council reviewed and renewed the proclamation of the existence of a local emergency within the City on the 15<sup>th</sup> day of May, 2023; and

**WHEREAS**, California Government Code section 8630 requires the City Council to review the need for continuing the Local Emergency at least once every sixty (60) days; and

WHEREAS, the City Council hereby finds that the above described conditions of extreme peril have not abated, and based on the large amounts of snow now accumulated in the Sierra Nevada Mountains, which when melted will flow into the San Joaquin River, are likely to worsen, and that as a result, the existence of a local emergency continues within the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Firebaugh as follows:

1. The Proclamation issued by the City of Firebaugh Director of Emergency Services on March 11, 2023, is hereby continued. The City Council further finds that the conditions constituting an emergency and threat to the safety of all persons and property of the City of Firebaugh will continue to exist so long as the San Joaquin River continues to run at flood levels.

2. The need for continuing this local emergency shall be reviewed as required by Government Code section 8630 and the City Council shall proclaim the termination of this local emergency at the earliest possible date that conditions warrant.
