The City of Firebaugh's Electric Light Parade has long been an event where families, neighborhood groups and businesses from across the city come together to provide an outstanding, family friendly, holiday themed special event that is enjoyed by hundreds of families each year. We invite each of you to make this a tradition for your family, organization, or business by participating in this year's parade.

Key Parade Information:

No live Santa's are allowed. Santa's may be depicted in other ways such as wood cut outs, balloons, blow-ups, etc. The real Santa will be escorted at the end of the parade by the Fire Department.

Parade Registration:

- The parade will be held Saturday, December 6, 2025.
- Check in will be at City Hall (1133 P Street) located at the corner of P Street and 11th Street.
- Registration begins at 2:00pm and promptly closes at 5:00pm. Anyone arriving after closing time can participate in the parade but will not receive an entry number and will not be judged.

Parade Route:

- Parade begins on the corner of "O" Street and 8th Street and ends at the corner of "O" Street and 12th Street. Please DO NOT stop at the intersection to unload – continue to City Hall parking lot for unloading.

Parade Rules & Regulations

Please communicate these rules to everyone in your group. Failure to comply with these rules and or instructions from parade officials could result in removal from the parade line-up or the loss of an award if the group is a competing entry. Thank you for your understanding and compliance.

- <u>NO LIVE SANTAS ON YOUR FLOAT! Santa may be depicted in other ways such as wood cut outs, balloons, blow-ups, etc. Santa will be escorted at the end of the parade by the Firebaugh Fire Department.</u>
- You must create your own design and provide your own supplies.
- All entries MUST complete the entire Parade route.
- All state laws and city ordinances must be followed. (i.e., kids wearing bicycle helmets.)
- ABSOLUTELY NO CANDY OR FAVORS ARE TO BE THROWN FROM FLOATS OR VEHICLES. This creates a very dangerous situation for children running into the middle of the parade route with motorized vehicles. If you want to distribute something, you must use walkers, who should try to be in costume consistent with float theme. THROWING ANYTHING FROM A MOVING VEHICLE WILL BE GROUNDS FOR REMOVAL FROM THE PARADE ROUTE.
- All float riders must always stay on the float. DO NOT allow riders to hang any body parts over the sides.
- All animals must be always supervised by adults.
- Drivers of motorized vehicles must be 18 or over and must hold a valid license.
- Drugs, alcohol, and tobacco use are not permitted on City property and along the parade route. If conduct is inappropriate, you will be asked to leave and you will be disqualified.
- Entry numbers identifying your group/club must be displayed on entries. Display numbers must be on the right side of windshield or on right shoulder of horse rider.
- We request that all walking entries please wear their uniforms or matching attire and carry a sign or banner that identifies the group.
- Loud noises such as sirens, car motors and motorcycle revving are discouraged since these can frighten children and animals.
- FESTIVE ATTIRE IS STRONGLY ENCOURAGES for participants including parents and chaperons.
- The Christmas Electric Light Parade is a rain or shine event. Please ensure your organization has appropriate weather-related provision.

1. DIGNITARY/CIVIC ENTRY: NON-JUDGED
