# **PUBLIC COMMENT**

Stephanie Gonzales suggested adding more context to agenda items to help residents provide more informed public comments. She noted that because public comment occurs before the Council's discussion, residents often lack clarity about key issues or questions the Council will be considering. She proposed that the Council provide a brief outline or summary of main points or discussion questions for each agenda item in advance, so the public can better understand the topics and offer more meaningful input. Gonzalez acknowledged the longstanding rationale for taking public comment first—ensuring neutrality and uninfluenced input—but encouraged the council to consider an alternative structure that offers residents a clearer context while preserving the integrity of the process.

- ▶ Public Works Director/Fire Chief Michael Molina Staff reported that the restroom at Maldonado Park will be closed after 3:00 p.m. due to ongoing vandalism, unless a solution can be identified to prevent further damage. Staff also noted that the street sweeper is out of service again. Options such as renting equipment or contracting the work have been explored; however, contractor services are estimated to be between \$10,000 and \$12,000. A request for a quote has been submitted to Mid-Valley, but no response has been received to date.

- Council Member, Renteria Requested updates on the Starbucks project, Fire Department Tax, sidewalks in the Del Rio area, Employee's Training report, and Mid-Year review. City Manager responded that the city has provided all the possible assistance available, but it's a legal issue between PG&E, Starbucks, and Family Dollar. Staff have started working with the consultant on the parcel tax for the Fire Department. The sidewalks were put on the City's CIP (Capital Improvement Plan) as a project to be funded with CMAQ allocated funds. Staff were directed to report all employees' training in their staff reports. The Finance Director stated the Mid-Year budget review will be presented in January of 2026.
- > <u>Council Member Valdez</u> At the last Council meeting, there was a presentation regarding the dog shelter project. I'd like to know where we were at with the project, where we should be, and where we fell short at the next council meeting. I also request that the Council provide clear direction to the City Manager to reach out to the donor to establish or re-establish a working relationship. I would like this item to be placed on the next agenda: an update on the project's current status, including the complete progress and the remaining steps. Additionally, I request that the Council consider providing consensus direction for the City Manager to move forward with the portion of the project that has already been funded. It is important that we demonstrate our commitment to this project; by doing so, we will be in a stronger position to re-engage the donor in hopes that he may reconsider his contribution toward the building structure.

# PUBLIC COMMENT ON CLOSED SESSION ITEMS ONLY

Ms. Janet Yergat addressed the Council and stated that she has been working on the animal shelter project for more than two years. She reported that she had secured contact with a prospective donor for a new animal shelter structure and believed the donor was eager to contribute to the City. She expressed concern regarding the difficulty in moving forward with the completion of donations and stated that the City should not decline financial assistance, particularly given the budget constraints common in small municipalities.

Ms. Yergat further stated that volunteers were lost through this process because they felt disrespected and unappreciated. She noted that there were extended periods without communication—sometimes lasting days or weeks—which had delayed progress. She referenced the duties of the City Manager and asserted that, in her view, those responsibilities had not been adequately fulfilled by Mr. Gallegos. She concluded by stating that, as representatives of the community, the Council should not issue a positive evaluation.
